### **2. No Agency:**

Neither party is authorized to act as an agent for, or legal representative of, the other party. Except as provide herein, neither party shall have the authority to assume or create an obligation on behalf of, in the name of, or binding upon, the other party.

### **3. Cancellation:**

Organizer shall not be liable to any sponsor for losses arising out of, or the inability to perform Organizer's obligations under the terms of this sponsorship proposal due to acts of God, which include, but are not limited to, fire, floods, tornados, severe inclement weather, strikes, mechanical failure, or any other acts beyond the control of Organizer. In the event of cancellation of the Event due to these aforementioned acts, Organizer shall refund such portion of the 50% refundable sponsorship dollars that have not been already expended by Organizer as of the date of cancellation.
