I strongly support the City of Prairie Village adding sexual orientation and gender identity as protected classes to their non-discrimination ordinance (NDO).

The city of Prairie Village is composed of and welcomes diverse individuals, groups, and communities. Discrimination and discriminatory practices based on real or perceived race, color, religion, national origin, sex, sexual orientation, gender identity, age, disability, marital status, familial status, or military status inhibit and restrict the economic growth and opportunities of Prairie Village and its residents and visitors, as well as the cultural, social, and commercial activities and life of our city. We want the City of Prairie Village to send a clear message that all people are welcome, and all people are protected from bias-driven crimes in this inclusive city.

It should be the intent of the City of Prairie Village that no person shall be denied their civil rights or discriminated against. This ordinance would not deny rights to any religious organizations. Passing this ordinance to protect the LGBTQ+ community will encourage economic growth of the city, raise revenue for the city for the benefit of its residents, prevent activities that jeopardize the public health, safety, peace, or morality of the city, provide for the health, safety, and welfare of the city, and the ability of its residents to fully participate in the cultural, social, and economic life of the town.

Prairie Village would join a growing list of states and localities with comprehensive LGBTQ+ Non-Discrimination protections. Please pass this ordinance and bring our laws into the 21st century to ensure that everyone in our city is judged on their merits, can provide for their families, and live free from fear.
