

CITY COUNCIL CITY OF PRAIRIE VILLAGE JANUARY 21, 2020

The City Council of Prairie Village, Kansas, met in regular session on Monday, January 21, 2020, at 6:00 p.m. in the Council Chambers at the Municipal Building, 7700 Mission Road, Prairie Village, Kansas. Mayor Mikkelson presided.

ROLL CALL

PLEDGE OF ALLEGIANCE

APPROVAL OF AGENDA

Mr. Nelson made a motion to approve the agenda for January 21, 2020. Mr. Herring seconded the motion, which passed unanimously.

INTRODUCTION OF STUDENTS & SCOUTS

A student from Shawnee Mission West was in attendance as a requirement of his Journalism class.

PRESENTATIONS

Stuart Little and Mallory Lutz of Little Government Relations spoke about representing a coalition of Northeast Johnson County cities as lobbyists in Topeka. The firm has represented the City of Merriam for many years, and has recently agreed to work with the cities of Mission and Westwood Hills. The fee to represent Prairie Village would be \$10,000 annually.

Ms. Nelson asked what services would be provided to best suit Prairie Village. Dr. Little stated that items such as economic development tools and transportation planning could be tailored to the City's needs.

Mr. Herring asked how the company would address situations in which Prairie Village's interests did not align with its other clients. Dr. Little stated that issues which might conflict



with existing clients would be clarified prior to an agreement being finalized and continuously throughout the duration of the contract.

PUBLIC PARTICIPATION

Mayor Mikkelson said that this public participation session was only for issues not related to the Breed Specific Language Ordinance discussion. With no one present to address the Council on other topics, public participation was closed at 6:19 p.m.

CONSENT AGENDA

Mayor Mikkelson asked if there were any items to remove from the consent agenda for discussion.

Mrs. McFadden asked that item #3 be considered separately, as she would need to abstain from voting.

COMMITTEE REPORTS

Mr. Nelson reported that the Future of the Arts Reception was held on January 10.
 He noted that attendance was good even though the weather was poor.



- Mrs. Myers said that the survey results for the proposed civic center were available to be viewed on the City website.
- Ms. Reimer shared that she attended the first 2020 meeting of the United Community Services' Drug and Alcoholism Council. A Sheriff's Deputy gave a presentation on trends in illegal drug use in Johnson County.
- Mrs. McFadden stated that the VillageFest Committee would meet on January 23.
 The committee is open to volunteers.

On January 15, Ms. Selders and Mrs. McFadden hosted a Parks and Recreation Committee meeting, at which a presentation was given by Dennis Patton on the Wassmer Park demonstration garden.

- The Mayor attended the Johnson County NAACP Martin Luther King, Jr. dinner, at which Major Byron Roberson received a law enforcement award.

- The Northeast Johnson County State of the Cities annual luncheon will be held on Thursday, January 23.
- The Mayor will take a tour of the YMCA program at Highlands Elementary with Representative Sharice Davids on January 23.

Mr. Poling made a motion that the City Council move to the Council Committee of the Whole portion of the meeting. The motion was seconded by Mr. Nelson and passed unanimously.

COUNCIL COMMITTEE OF THE WHOLE

COU2020-04 Discussion regarding the removal of Breed Specific Language as specified in Ordinance 2-105



Mrs. Myers asked Chief Schwartzkopf to provide information about how vicious animals are handled in the City. The Chief stated that in 2017, an Ordinance regarding potentially dangerous, dangerous and vicious animals was passed by Council and added to City Municipal Code. He noted that the language was added under the assumption that the Breed Specific Language Ordinance might be repealed in the future.

Ms. Nelson gave a presentation showing the difficulty determining the breed of a dog based on appearance alone. She provided information stating that aggressiveness is not specific to a dog breed, but rather to individual dogs themselves. Finally, she noted that 28 Kansas cities had repealed pit bull bans since 2008, and that Prairie Village was one of only seven cities in the Kansas City Metropolitan Area that still had bans in place.

Ms. Nelson moved for staff to draft an ordinance that repeals Section 2-105 of the Municipal Code. The motion was seconded by Mr. Poling.

Mr. Gallagher suggested that the motion be retracted and the issue be continued to the February 3, 2020 meeting, so that those in favor of maintaining the ban had an opportunity to speak. Ms. Nelson stated she would not retract the motion.

Mrs. McFadden said that the number of dog bites in the City were still high, and felt that more work needed to be done to reduce them before repealing the Ordinance. Mr. Runion stated that he would support a motion to have staff further review information on the topic. Mr. Nelson added that federal law prohibited cities from banning pit bulls if they are being used as service animals.

The motion passed 9-3, with Mrs. Myers, Mr. Runion and Mrs. McFadden in opposition.

2019 Exterior Grant Program changes

Mrs. Robichaud stated that at its January 6 meeting, the Council Committee of the Whole approved raising the appraised value threshold for the 2020 Exterior Grant Program to \$250,000, but directed staff to come back with a list of options for adding projects to the eligible projects list that would improve environmental sustainability as well as identify additional funding options. She noted that staff had identified three options for consideration:

- Option 1: Continue the Exterior Grant Program as it currently operates and consider creating a new, separate grant program to assist residents with paying for environmentally-friendly improvements.
- Option 2: Expand the Exterior Grant Program to include environmentally-friendly projects that are on the exterior of the property only.



 Option 3: Revise the Exterior Grant Program to include projects on both the exterior and interior of the home that would include projects that improve a home's environmental sustainability.

Mrs. Robichaud said that staff recommended proceeding with Option 1 and setting the 2020 Exterior Grant budget at \$68,000. Additional funding would include \$18,000 from the minor home repair program. Furthermore, a portion of the current \$400,000 in unallocated funds could be utilized to finance an environment sustainability grant program.

Mr. Herring asked how many exterior grant applications were unfulfilled in 2019 due to a lack of funding. Mrs. Robichaud stated that there were seven projects, which could have been funded with the proposed 2020 budget.

Mr. Herring made a motion to move forward with Option 1, set the 2020 Exterior Grant budget at \$68,000, and direct staff to draft environmental grant program options for the Council's consideration. The motion was seconded by Mr. Nelson, and passed unanimously.

Ms. Limbird moved that the City Council end the Council Committee of the Whole portion of the meeting. The motion passed unanimously.

ANNOUNCEMENTS

Announcements were included in the Council meeting packet.

ADJOURNMENT

With no further business to come before the City Council, Mayor Mikkelson declared the meeting adjourned at 9:41 p.m.
