



Virtual community meeting scheduled for Village Vision 2.0

The City has been working on refreshing and updating its Comprehensive Plan – Village Vision 2.0 – for the past 18 months.

The original Village Vision was adopted in 2007 and contains recommendations on issues ranging from redevelopment, to land use, to community services and amenities. Many of the goals outlined in the original Village Vision plan have been accomplished, so the City began a process in 2019 to refresh the Comprehensive Plan to make it more relevant to the current and future community challenges and opportunities that face Prairie Village.

A draft of the refreshed Village Vision 2.0 is available on the City's website at pvkansas.com/villagevision2.0.

The City will be holding a virtual infor-

mation session on September 9 at 6:30 p.m. via Zoom. Residents will have an opportunity to ask questions and provide input during this virtual community meeting as well as hear more about what the new plan entails. The details for joining the meeting via Zoom are online at www.pvkansas.com. If you are unable to attend the virtual meeting, you can still review the draft document and provide comments through the survey included on the City's website. With resident input, Village Vision 2.0 will be finalized this fall and replace the existing Comprehensive Plan that was adopted in 2007.

A Message from the Mayor



Dear friends and neighbors,

In strange and challenging times, great things are happening in Prairie Village.

The community came together to battle this unprecedented pandemic. You are social distancing, wearing your masks, washing hands, caring for your neighbors, and doing your part. We must remain vigilant, including for the sake of our children and the schools!

We haven't stopped accomplishing "ordinary" great things too. Allow me to share three exciting civic updates.

City Finances and 2021 Budget. With belt-tightening in non-essential areas, our fiscal performance so far in 2020 is strong. Through the

second quarter, our expenses were 45% of the annual budget amount. Our expenses were less during the first six months of 2020 than they were during the same period in 2019. We expect to take a hit to revenues related to the pandemic. But because Prairie Village is not as dependent on sales tax as some other cities, our outstanding finance staff, and our tradition of conservative budgeting principles, so far the City is doing better than expected. Overall revenues through the first six months of 2020 were slightly higher than in 2019.

For 2021, we adopted a budget that fully funds city services and amenities including streets, parks and police, holds the main property tax mill rate steady, reserves a "rainy day" fund, and also reduces the tax/assessment rate for solid waste on property tax bills by 4.4% per household. This budget includes upgrades to our aging infrastructure in city buildings, the pool, parks (including adding restrooms), streets and drainage. Bolstered by our clean audit and recent "triple A" (Aaa) bond rating, Prairie Village remains in excellent financial condition despite the fierce economic storm raging around us.

New Business Openings (and Reopenings). Our local businesses are essential to our high quality of life. Many of them were knocked down hard by pandemic closures. With your help, they are standing back up again with protective health protocols in place. We have several new business investments including our first and only hotel (The Inn at Meadowbrook), new restaurants (Verbena and The Market also in Meadowbrook Park), Summer Salt Ice Cream in the Corinth Shops, Chill in the Village Shops, the Sharp Law Firm, 2020FIT, Corinth Quarter and more. Please support them with your patronage!

Diversity. Prairie Village is one of the best places to live on the planet. We continue to receive independent affirmation of that, including a 2020 ranking as the "#1 Best Place to Live in Kansas" and the "#1 Best Place to Live in the Kansas City Area." However, one of our biggest opportunities for improvement lies with increasing diversity of our residents. We have a unique moment in history right now to seize momentum toward that goal. Your Council, staff, police and I are united in encouraging and celebrating diversity in Prairie Village. You will continue to see expanded policy and events including housing/development, sustainability, arts, hiring, training, policing, programming, and funding to make it so.

Our residents and staff amaze through the toughest times Prairie Village has ever seen. Sometimes it seems too much just to contend with these dangerous global challenges. To do that with such grace and skill, and at the same time add local improvements for our public benefit, demonstrates why Prairie Village, while not perfect, is close to the best a City can be.

Census takers finalizing count door-to-door

Census takers have begun visiting households that have not responded to the 2020 Census. You don't have to wait to be counted. Respond to the census today at https://my2020census.gov or call 844-330-2020.

Every 10 years, the U.S. Census Bureau counts each resident in the United States. Approximately \$800 billion in federal funding is distributed to communities each year based on the population totals collected by the census. This federal funding supports parks, literacy programs, senior services, affordable housing, schools, health clinics, fire stations, veterans programs, job training, community centers, and hundreds of other critical services and programs. Data collected in the U.S. Census brings the right amount of federal money to the local community for these programs that help you and your neighbors. For each household that doesn't get counted in Prairie Village, our community loses \$46,845 in federal funding over a 10-year period, according to information provided by the League of Kansas Municipalities.

The 2020 Census will conclude September 30. Be sure you are counted before then.

Joint statement from the City of Prairie Village regarding racial justice

As elected leaders who represent the City of Prairie Village, our hearts are heavy following the tragic and senseless killing of George Floyd and other people of color wrongfully killed or brutalized by police or armed vigilantes. Mr. Floyd's death, and others who have died at the hands of prejudice, have evoked pain and anger for many within Prairie Village and throughout the nation. So their deaths will not be in vain, we pledge to fight systemic and individual racism. The countless number of race-related crimes against Black people throughout history and continuing to the present is appalling, inexcusable, and unacceptable.

Let us give words meaning through our actions and solemn oaths to protect the humanity, dignity, and civil liberties of all we serve. We recognize that racism is, tragically, ingrained in our society. We recognize that racism comes in many forms, including not only overt racial hatred but also insidious unconscious biases. We stand ready to proactively educate ourselves about all aspects of racism in our society and ourselves. We pledge to listen to the voices and experiences of people of color even when those perspectives challenge us. We stand united to address racism in our own community through ongoing review of organizational policies and procedures, the services we provide to our citizens, our schools, and our criminal justice system. Our community lacks diversity in large part because of our shameful history of racial segregation, including redlining and segregated deed restrictions. We must work to increase diversity in Prairie Village, and the culture of our city government must reflect a continuous fight against injustices that would preclude a racially diverse Prairie Village.

We support the rights of the public to peacefully assemble to honor those who have been victims of racism and violence. We reject the militarization of police forces. Police should be guardians, not warriors. We encourage public dialogue and debate. We invite conversations related to improving diversity and inclusion in Prairie Village. Today and every day, we stand with the Black community. We stand with those who call for constitutional justice, social equity, and basic human rights. We continue our pursuit of the notion that all people are created equal. While racism did not start in our lifetime and will not end in our lifetime, we pledge to work tirelessly against it in our lifetime.

As Prairie Village businesses re-open to the public following stay-at-home orders related to the COVID-19 pandemic, residents can look online to see how merchants are following recommendations for safety and sanitation. Face masks required in **Prairie Village**

Effective July 3, face masks or cloth face coverings are required to be worn in Prairie Village in accordance with Kansas Governor Laura Kelly's statewide order.

The City of Prairie Village has ordered a supply of singleuse masks that are available to local businesses for distribution to customers without masks of their own. The Prairie Village Police Department will also have single-use masks available individual community members in need of them.

According to the Governor's statewide orders, masks or cloth face coverings are required in the following situations:

- Inside, or in line to enter, any indoor public space
- Obtaining services from the healthcare sector in settings, including but not limited to, a hospital, pharmacy, medical clinic, laboratory, physician or dental office, veterinary clinic, or blood bank (unless directed otherwise by an employee or healthcare provider)

- Waiting for or riding on public transportation or while in a taxi, private car service, or ride-sharing vehicle
- While outdoors in public spaces and unable to maintain a 6-foot distance between individuals (not including individuals who reside together) with only infrequent or incidental moments of closer proximity

The Governor's orders also state businesses and organizations must require all employees, customers, visitors, members, or members of the public to wear a mask or cloth face covering when:

- Employees are working in any space visited by customers or members of the public, regardless of whether anyone from the public is present at the time
- Employees are working in any space where food is prepared or packaged for sale or distribution to others



- Employees are working in or walking through common areas, such as hallways, stairways, elevators, and parking facilities
- Customers, members. visitors, or members of the public are in a facility managed by the business or organization
- Employees are in any room or enclosed area where other people (except for individuals

who reside together) are present and are unable to maintain a 6-foot distance except for infrequent or incidental moments of closer proximity.

Together Apart





Save the Pollinators

Have you wondered why we have fewer pollinators in Prairie Village? Pollinators are declining worldwide - butterflies, bees, fireflies, moths, and many other pollinators and insects. Many songbird populations are in decline as well. You can help alleviate this problem by altering how you clean up your yard as well as minimizing the use of pesticides. Pollinators winter over in or on leaves, stalks of plants, and even in the ground. Yes, bears and other mammals are not the only living creatures that hibernate. For most of the year, pollinators spend time in their nests, gather pollen, and reproduce. We only see them for 8 weeks of their adult lives after emerging. Unsustainable gardening practices are interfering with their ability to reproduce and are contributing to their decline. What can we do?

Save the leaves. Many cocoons and eggs live in fallen leaves. When raking, consider using fallen leaves on the ground around your trees, where not much grass grows, or under your bushes for mulch, anytime of the year. Leaves and debris can be left undisturbed in your flower beds.

Let the stems stand. Several species of pollinators nest and/or make cocoons inside or on the stems of plants. Consider cutting only those stems located a foot or two closest to the edge of your garden. Leave the rest to fall on their own. By May the foliage will have grown high enough that the debris won't be seen. The top 10-12 inches of stems of plants can also be cut, bundled together, and left to rest against a building for the winter. Leaves and debris can be moved any time of the year, but not too far as some pollinators have only a short flight distance. Pollinators cannot get through wood or stone mulch, landscape fabric or plastic, so use ground leaves or grass for mulching if desired.

Disturb the soil as little as possible. Considering using No-Till Gardening. Rototilling 6-10 inches into the ground destroys the soil structure as well as harms the nests of bees, wasps, and other bare ground nesting insects.

Minimize pesticide use as these wash into their nests.

Think of the enjoyable activities available to you with time saved from less yard clean up. Many local experts are knowledgeable in how planting native plants - flowers, vegetables, shrubs and trees - can help our pollinators and our environment in general. Deep Roots KC, our local non-profit organization on native plants, held a Native Gardening webinar series during the stay at home order. Police Department cautions residents about phone scams

One of the most common tools criminals use to scam victims is the phone. Scammers have figured out countless ways to cheat people out of their money over the phone. In some scams, they act friendly and helpful. In others, they might threaten or try to scare you.

Here are some tips on what to do if you receive one of these calls and how to recognize if it may be a scam:

- If you did not sign up for something and are not expecting notifications, hang up.
- · Gift cards as payments should alert you that
- If the caller request a "down payment" or "service charge" before claiming a prize, it's a scam.
- · If the caller threatens to arrest you if payments are not made, it's a scam; hang up.
- If it seems too good to be true, it probably is.

Door-to-door solicitation guidelines

Door-to-door solicitation is a common business practice that may bring strangers to your neighborhood. It's important to know your rights and what you can expect from licensed solicitors.

Door-to-door solicitation is the practice of going onto private property unannounced with the intent of selling goods or services for a profit. This includes selling, offering to sell and taking orders for goods or services. In the past, City ordinances strictly prohibited any form of door-to-door solicitation. While many residents supported the blanket prohibition, several courts have declared ordinances nearly identical to the Prairie Village ordinance as unconstitutional.

The City's current solicitation ordinance was written with the safety of residents in mind. According to the City's door-to-door solicitation ordinance:

For-profit solicitors:

- Must obtain a permit from the City and display it while soliciting in Prairie Village.
- May call on residences between 10:00 a.m. and 5:30 p.m. and from 7:00 p.m. to 8:00 p.m.
- May not call on or approach any residence displaying a "No Solicitation," "No Trespassing" sign or any other similar notice.
- Must wear photo I.D. at all times.
- Must leave a resident's property when directed to do so by the resident.

Residents may:

- Require a solicitor to present his or her permit and photo identification.
- · Obtain "No Solicitation" stickers free of charge at the Prairie Village Municipal Building or Police Department Lobby. A "No Solicitation" notice can also be clipped out of page 11 of this Village Voice.
- Require the solicitor to provide a receipt for any purchase exceeding \$5.00.
- Contact the Police Department at 913-642-6868 if a solicitor comes to a door when the home is posted "No Solicitors."



Prairie Village launches redesigned website

Over the summer, the City of Prairie Village launched a redesigned website with features intended to enhance usability.

The website, which is still located at www.pvkansas. com, was redesigned by Granicus, a company that specializes in technology solutions for government agencies. Granicus used heat-mapping and website analytics to determine which pages website visitors were most interested in, and site content was reorganized accordingly.

The redesigned site also has several new features. An accessibility widget, powered by Userway, can be found in the upper right corner of the page. It allows users to customize their experience to make the site easier to navigate.

The service finder, also located in the upper right corner of the homepage, helps visitors easily locate various services and programs either by department or by category.

New call-to-action buttons in the middle of the homepage highlight services and departments residents search for most often on the page.

The redesigned website was recreated with mobile users in mind. The mobile homepage features a series of buttons designed to make content easier to access.

Find your election information

Voter registration closes 21 days before any election. That means if you aren't already a registered voter, you must register by October 13 if you wish to vote in the November 3 General Election. In Kansas, you must reregister each time you change your name, address, or party affiliation for voting.

Please note, you CANNOT register to vote at City Hall, but you can do so online at https://www.kdor.ks.gov/Apps/VoterReg/Default.aspx. You can also download a paper registration form in English or in Spanish at https://sos.ks.gov/elections/voter-information.html. Paper forms must be mailed to the County Election Officer using the information on the form.
