Opticom System

The City recently completed installation of the 3M "Opticom" Priority Control System at several signalized



intersections within the City. This system will give Police, Fire, and Med-Act vehicles responding to emergencies priority upon approach to these particular intersections.

The "Opticom" system will recognize the approach of an authorized

emergency vehicle and then provide it a green light right-of-way and at the same time provide a red light for traffic approaching from other directions. The changing of the traffic signals will be done within timing parameters set by traffic engineers so it appears as a normal change of the traffic lights to other motorists. The use of this system will provide a quicker and safer response by authorized vehicles in route to any emergency within the City.

Winter Reminders

With winter upon us, the snow and the ritual of plowing and salting streets and shoveling driveways has begun. These weather extremes and changes bring a special challenge to Public Works employees who strive to keep your streets usable in the winter months.

When a storm is forecast, Public Works staff develops an operation plan considering time of day, type of weather, temperature, wind, length of storm, etc. Crews work in 12 hour shifts to clear streets using these priorities:

- 1. Maintain bare pavement on arterial streets
- 2. Maintain bare pavement on collector streets
- 3. Maintain public building sidewalks
- 4. Plow or salt one lane on residential streets
- 5. Maintain sidewalks at the parks.

The City does not remove ice or snow from private property. Property owners are responsible for removing ice and snow from the sidewalks abutting their property. The best time to do this is after the street has been plowed.

Animal Licensing Reminder

The licensing year for cats and dogs is January 1st to December 31st. The City asks that you license your pets in January and February. After February 28th penalties will apply.

PLEASE NOTE THE NEW CHANGE: An animal may be licensed if its rabies vaccination is current at the time of licensing, unlike previous years when the vaccination had to be valid the entire licensing year.

The 2002 fee schedule for licensing your animals is as follows:

January – February

\$6.00 (neutered/spayed) \$12.00 (not neutered/spayed)

March 1 - March 31

\$7.00 (neutered/spayed) \$14.00 (not neutered/spayed)

April 1 – April 30

\$8.00 (neutered/spayed) \$16.00 (not neutered/spayed)

May 1 – December 31

\$18.00 (neutered/spayed) \$26.00 (not neutered/spayed)



Consolidated Fire District No. 2 Safety Tips when burning candles

Last year, most Fire Departments in Johnson County noticed a marked increase in the number of fires caused by candles. Not only were the incidents last year increased, but the number of home fires caused by candles over the last 10 years doubled. Research into this problem indicates that it is due to the popularity of decorative and scented candles.

Data collected by the National Fire Prevention Association (NFPA) revealed that in 1998 there were 11,600 home candle fires reported. Approximately one third of those fires began when candles were left unattended. If you use candles, please remember that a candle is an open flame. It can easily ignite anything combustible nearby.

Consolidated Fire District #2 and the NFPA offer the following tips for the safe use of candles:

- Use candles only with constant adult supervision.
- Extinguish all candles when leaving a room or going to sleep.
- Keep candles well away from items that can catch fire, such as flammable decorations, clothing, books, paper, curtains, etc.
- Make sure candles are placed on a secure piece of furniture, in sturdy holders that will not tip over. Make sure candleholders are non-combustible and big enough to collect dripping wax.
- Do not place lit candles in windows, where blinds or curtains can close over them.
- Keep wicks trimmed to 1/4 inch, and extinguish candles when they burn down to within two inches of the holder.
- Keep candles and all open flames away from flammable liquids.
- Do not use candles in places where they can be knocked over by children or pets.
- Try to avoid carrying a lit candle.

Where young children are present:

- Keep candles up high, out of reach of children.
- Never leave a child unattended in a room with a candle. A child should not sleep in a room with a lit candle.
- Keep all matches and lighters up high and out of the sight and reach of children, preferably in a locked cabinet.

A smaller group, working as a steering committee, examines and develops positions and makes recommendations on those issues. The steering committee, made up of approximately 35

elected municipal officials, submits its recommendations to the full committee for further consideration at the 2002 Congress of Cities. After review by the full committee, policy amendments are brought before the NLC membership at the annual business meeting. Once approved by the League's membership, the NLC National Municipal Policy serves as the basis for the League's advocacy on behalf of all local governments.

The League, headquartered in Washington D.C., is the nation's oldest and largest municipal organization, with a membership of more than 1,700 cities and towns and a national representation of more than 15,000 municipal governments throughout the United States.
