Recycling Changes Begin January 1st

Remember – changes to the City's curbside recycling program will take place this month. **Starting January 1st, 2003, glass will no longer be accepted for curbside recycling** for residents participating in the City's Solid Waste Management Program. However, you will be able to recycle a wider variety of paper products, including corrugated cardboard, chipboard (cereal boxes) and carrier stock paper.

To prepare items for curbside recycling: Place aluminum cans, steel cans, and plastic containers directly into the recycling bin. Remember to rinse out cans and containers before placing them in the bin.

Newspapers, magazines, telephone books, catalogs, junk mail, and other "slick stock" papers may be placed directly into the recycling bin or into paper grocery sacks. If you choose this method, please separate newspapers from other types of paper. Papers or any other recyclables placed in plastic bags WILL NOT be collected.

Chipboard (cereal boxes) cardboard, and carrier stock paper should be flattened and placed directly into the recycling bin or into paper grocery sacks. All plastic liner bags found in cereal boxes and other chipboard type boxes should be removed and thrown away in the regular trash.

Corrugated cartons should be flattened into pieces approximately 2' x 2' and placed **under the recycling bin**. If you have a large amount of corrugated cardboard, please bundle it to keep it from blowing away.

It's Time to License your Animal for 2003



City ordinance requires the annual licensing of all cats and dogs residing in the City. The ordinance also requires proof of a current rabies vaccination for licensing.

NOTE: The vaccination does not have to be valid throughout the calendar year, but must be valid at the time of licensing. THEREFORE, ALL PETS SHOULD BE ABLE TO BE LICENSED IN JANUARY AND FEBRUARY. The license fee for a spayed or neutered pet is \$6. The fee for an animal which has not been spayed or neutered is \$12.

Mayor's Message



From time to time I hear comments that the State government isn't involved in the day-to-day lives of Prairie Village residents. Nothing could be further from the truth. During my years of service as a Council member, and now as Mayor, I've learned that actions taken in Topeka

do, in fact, have a major effect on life in Prairie Village.

Here are just a few ways the State Legislature touches our lives in Prairie Village:

The State provides the bulk of funding to public schools, including the Shawnee Mission School District. Without the full and active participation of the State, it will be difficult for our public schools to maintain their excellent reputations.

The State provides a significant amount of money to local governments, including Prairie Village. In 2003, the City expects to receive over \$250,000 from the State in "demand transfers." These funds help reduce the City's reliance on property taxes as a source of revenue.

This year, the City expects to receive over \$650,000 in Special Highway Funds. This money helps finance the maintenance of City streets. Without this type of assistance

from the State, it would be difficult, if not impossible, to maintain the high quality of the City's streets without significant increases in property taxes.

The Kansas Legislature will begin its 2003 session on January 13th. Given the State's critical financial situation, our State Senators and Representatives will be making some very important, but difficult decisions regarding the State's budget crisis.

This year it will be more important than ever to follow the activities in the Kansas Legislature. But we can all do more than be passive observers. We can and should let our elected officials know how we feel about the issues. Our elected representatives value our opinions. I encourage all Prairie Village residents to contact your State Senator and Representative.

Winter Safety Reminders from the Fire District

Now that winter is approaching we would like to remind everyone to use extreme caution when utilizing home heating equipment. **Home heating equipment is the**

leading cause of home fires during the months of December, January, and February.

Common causes of home heating fires are:

• Creosote build-up in wood burning stoves and chimneys, caused by the lack of regular cleaning.

- Placing combustibles too close to home heaters
- Improper fueling of gas heating equipment.

Please follow these safety tips:

Have all wood burning stoves, fireplaces, chimneys, and flues inspected annually by a professional and cleaned accordingly. Portable space heaters need a three foot clearance from anything that can burn and should always be turned off when leaving the room or going to sleep.

Portable kerosene heaters must be fueled only in a well ventilated area, free from other heat sources and open flames, and only after the device has cooled completely. Use only the type of kerosene specified by the manufacturer for that device. **NEVER SUBSTITUTE**GASOLINE FOR KEROSENE.

A Reminder from the United States Postal Service

The United States Postal Service would like to remind residents to keep their sidewalks and areas around their mailboxes free from snow and ice this winter season.

With the winter season approaching, frigid temperatures can bring significant snow and ice. Unfortunately, inclement weather may cause mail delivery service to be delayed or curtailed when streets or walkways present hazardous conditions to postal carriers and/or vehicles. Letter carriers cannot make door or curb deliveries when the approach to the mailbox is hazardous because of a heavy buildup of snow or ice on sidewalks, steps or porches. And they are not allowed to dismount for curbline boxes or cluster boxes blocked by snow and ice buildup.

By clearing a path when the snow falls, proper access is provided to mailboxes. Proper access includes the removal of large accumulations of snow from the area approximately six feet on both sides of the mailbox or cluster box unit so the carrier may approach and leave without backing up his or her vehicle. Customers are responsible for ensuring proper access is provided to their mailbox. Without such access, the safety of the carrier is jeopardized and delivery service may be delayed or curtailed.

Remember that City ordinances also require property owners to remove ice and snow from sidewalks abutting their property.



Holiday Tree Recycling Program

The City will once again sponsor a Holiday Tree Recycling Program for Prairie Village residents. Trees may be dropped in the designated areas of **Porter, Franklin, and Meadowlake Parks**, and in the **Harmon Park parking lot near the water tower**. The trees must be free of all lights, ornaments, stands, and any metal nails, etc. as these items will damage the chipping machine. Residents may take the chips for their own use.


The program will continue until Monday, January 20th.

Are You Ready for the communicator!™?

The Prairie Village Police Department has added The Communicator notification system to its emergency communications network.

What is The Communicator?

The Communicator is a high-speed notification system capable of notifying the community of a potential threat to public safety in a matter of minutes. In addition to emergency notifications, The Communicator can also be used to notify residents of priority criminal activity, lost children or missing Alzheimer patients in their neighborhoods. Communities can then assist police in locating the missing parties or by calling in suspicious activity.

How does the system work?

The system runs off of **published** telephone numbers only. Those numbers are programmed into the mapping software, and when a particular area of the map is highlighted, the system will deliver a pre-recorded message to those residences, businesses or schools in that area. If you have a non-published number, your information will not be in the computer, and you will not receive a call. The use of The Communicator will be strictly limited to only send you messages regarding public safety, and it is not meant to relay messages of non-essential matters.

What do I do when I receive a call?

Residents are asked to take a few moments and listen to the pre-recorded message. The message will contain important information and instructions. Should you receive a message, and have information for the police, please call 913-642-5151 to inform the dispatcher. If you do not have any further information contact with the Department is not necessary.

What if my number is non-published and I want to be notified by The Communicator?

If you would like to be included in, or excluded from, The Communicator, please fill out the enclosed insert and follow the instructions on the form. If you would like to receive notifications on your cell phone instead of your home phone, please fill out the enclosed insert. All numbers provided will only be used by the Prairie Village Police Department and the lists of telephone numbers will not be given or sold to any other party(ies) outside of the Department.

The Communicator provides the Prairie Village Police Department a way to deliver accurate, time sensitive information, and solicit help from residents when it is needed.
