The City has retained HNTB Corporation to design street improvements for the 2007 Street Resurfacing Program. Currently we are in the concept phase which involves identifying which streets will be included in the program and what type of work is needed.

ON THE BACK:

Crime Prevention: What's in a Name? PV Notes be deleted or added based on budgetary restrictions. You will be notified approximately two to three weeks prior to construction if your street made the final list of streets to be resurfaced or reconstructed.

- **1. 81st Street (Lamar Avenue to Nall Avenue)** This street is scheduled for full reconstruction.
- **2. Birch Lane (87th Street to Rosewood Drive)** This street is scheduled for a mill and overlay.
- 3. Mohawk Drive (75th Street to 77th Street) This street is scheduled for full reconstruction. Please note that there is no scheduled work for the two cul-desacs within the project. If any work is done on the cul-desacs it would only be minor curb repairs if needed.
- **4. 73rd Street (Mission Road to Village Drive)** This street is scheduled for full reconstruction.
- **5. Briar Street (74th Terrace to 75th Street)** This street is scheduled for a mill and overlay.

- **6. Eaton Street (71st Terrace to 72nd Terrace)** This street is scheduled for a mill and overlay.
- **7. 78th Street (Booth Drive to Cambridge)** This street is scheduled for a mill and overlay.
- **8. 77th Street (Delmar to Fontana)** This street is scheduled for full reconstruction.
- **9. 75th Street (Nall Avenue to Mission Road)** This street rehabilitation is funded in part by the county.

In the past, the City has held public information meetings regarding proposed projects but this has historically had very little attendance. 2007 Animal Licensing

City Ordinance requires the annual licensing of all cats and dogs residing in the City.

The ordinance also requires proof of a current rabies vaccination. Now is the time to license your dog or cat for the 2007 licensing year.



NOTE: The vaccination does not have to be valid throughout the calendar year,

but must be valid at the time of licensing. Therefore, all pets can be licensed in January & February before late fees are assessed. The license fee for a spayed or neutered pet is \$6. The fee for an animal that has not been spayed or neutered is \$12.

Holiday Tree Recycling Program

The City will once again sponsor a Holiday Tree Recycling Program for Prairie Village residents. The trees must be free of all lights, ornaments, stands, and any metal nails, etc as these items will damage the

chipping machine. Residents may take the chips for their own use.

The program will be available from December 23rd, 2006 until January 22nd, 2007.



Ball Field Reservation Applications Due

Baseball Season will be here before you know it, and ball fields in Prairie Village are always in demand. Make plans now to reserve a practice field for your team.

The City of Prairie Village allows reservations of ball fields for soccer, baseball. and softball practices. Prairie Village (those teams with a majority of players who are Prairie Village residents or attend school in Prairie Village) will be given priority for field reservations, but any team may apply to reserve a field. Teams can reserve two practice times per week for up to 1-1/2 hours. Fields are available in Porter, Franklin, Windsor, and Meadowlake Parks.

If your team reserved a field during 2006, your coach should receive a 2007 application form soon. You may also obtain one at the Municipal Offices or online at www.pvkansas.com/parks. There is a \$50 reservation fee per team that must be submitted with your application.

The deadline for submitting applications is January 19, 2007.

Take Care of Your Neighborhood Mail Carriers!

As we were all reminded with the heavy snowfall last month, winter weather can mean slippery surfaces



for both you and your mail carrier.

Inclement weather may cause mail delivery service to be delayed or curtailed because of hazardous conditions such as snow buildup or snow and ice on sidewalks, porches or steps. Also, mail carriers are not allowed to dismount for curbline boxes or cluster boxes that are blocked by snow and ice buildup. To prevent mail delivery service from being delayed or curtailed, please ensure mail carriers have proper access to mail receptacles when snow This means removing arrives. large accumulations of snow from the area approximately six feet on both sides of the mailbox or cluster box.

If these precautions are taken, then you can feel good knowing that both your mail carrier and your mail are safe.

Open Ignition Ordinance

The Police Department would like to remind you that it is unlawful to leave the keys in the ignition of an unlocked and unattended vehicle. This ordinance was enacted to mitigate the ease of vehicles being stolen; specifically, when left "warming up." This ordinance applies to public and private property. The Department appreciates your help in preventing crimes of opportunity.

What's In a Name?

Who you are and what your name is may be the most important identity you "carry" with you everyday because it is who you are. The **Identity Theft** Predators know this and they want your name for their use as they try to steal your identity and make your name their name to use in a criminal nature.

Identity theft is when a person knowingly steals personal information which may include name, date of birth, or social security number to gain access to a person's financial accounts. The crook may also use the information to open up a new bank account, make purchases, or rent an apartment in the stolen person's identity.

In this month's crime prevention article we will address identity theft and what's in a name as you work and play in a high tech, online instant information society.

The following safety tips may help you keep your name and the bad guy can keep his name; crook.

- Shred any personal informational documents before throwing them away.
- Don't leave outgoing mail in your mail box.
- Be as mindful of whom you give information to over the telephone as you would while on the Internet.
- Protect your identification by never clicking on links sent to you in unsolicited emails. Use firewalls, anti-spyware, and antivirus software to protect your home computer.
- Avoid using obvious passwords like your birth date, the last four digits of your social security number, or home address.
- Periodically check your credit history and financial statements for any discrepancies.
- Store personal information in a secure place at home, especially if you are having work done in your home or you have a roommate or outside visitors.

These are just a few of the ways you can help keep your good name to yourself and live with the security and sense knowing that your name has not been compromised.
