


As you are enjoying the long-awaited spring weather, hopefully you have noticed the new Park Identification Signs located in your City's parks. The signs were a long-time effort of the Park and Recreation Committee and were designed to look similar to the City Entrance Signs. (A few signs have not been installed yet due to the upcoming improvements.) The new identification signs were the kick-off for implementing the **Parks and Recreation Master Plan**, adopted last year.

Starting in early spring, improvements to Franklin Park will begin. These improvements were presented during a public forum in January. Indigo Design, who also completed the City's Parks Master Plan, shared preliminary schematic designs with the public, the Parks & Recreation Committee and the City Council. Improvements to the park include widening the park trail to 8', the addition of a new park shelter, restroom facilities and nature-play elements allowing children of all ages to interact with their natural surroundings. The design phase

of the project has been completed and construction is set to begin in mid-May. The City anticipates disruptions to the central portion of the park to last until mid-September. As one of our community's most utilized parks, we understand this construction may disrupt your experience. Your patience is appreciated as we make these improvements.

Exciting improvements to **Weltner Park** are also currently being planned as well as other minor enhancements recommended in the Master Plan. SISTER CITY COMMITTEE



2010 finds the Sister City committee hard at work. Early in the year committee members hosted three visitors from our sister city of Dolyna, Ukraine. All three guests had previously visited Prairie Village and formed a bond with the committee members and residents they met. The

purpose of their visit was to spend time at local agencies to gain a greater understanding as to how they operate. Two of our guests, Oksana Yakymiv, Director of the School of the Blind in Dolyna and Larysa Galushyna an English teacher at the school were able to spend time and study the operations of the Kansas City School for the Blind. However, the visit was extra special for the third member of their party, Tetyana Seniv, Director of the Dolyna Museum. Born with debilitating cataracts, Tetyana's vision had progressively gotten worse throughout her life to the point that she would eventually become totally blind. In concert with Sister City committee members Vera Glywa and Cindy Dwigans, Prairie Village resident Nancy Wallerstein contacted Jim Denning with Discover Vision Centers. Those efforts resulted in a series of corrective surgeries for Tetyana not readily available to her in Ukraine. The Prairie Village Lions Club, other KC Metro Lions Clubs and concerned citizens raised money to help with the cost of

Tetyana's airline ticket. US Peace Corp Volunteers working in Dolyna, also helped to raise funds through their membership in their Alaskan Lions Club. Tetyana's cataract removal and Lasik surgery, by Discover Vision Center's Dr. John Doane, was able to correct her vision to 20/20. Tetyana said, "If it was not for the help from Vera, Cindy, Nancy, Discover Vision Centers and the Sister City Committee, I would have died not knowing there was so much beauty in the world."

In addition to hosting visitors from Ukraine, the Committee has been diligently preparing to host an April gallery showing at the Endres Gallery located in City Hall. In December, the Dolyna museum, where Tetyana is the Director, hosted a showing of works by their local artists. This provided an opportunity to develop their community involvement and volunteerism. Prairie Village chose works from the Dolyna showing to be shipped to the US specifically for the April show. This exhibition of Ukrainian art is a great example of the increasing partnership between our sister cities. In addition to these selected pieces, we have a variety of works by other Ukrainian artists, examples of folk art and handicrafts and pieces on loan from private collections. Join us April 9th from 6:30-8:00pm for the reception, and at 7:30 we will host a presentation on the exhibition and its cultural context.

Lifeguard and Operations Attendant Applications are Being Accepted

The City of Prairie Village is accepting applications for lifeguards and operations attendants for the 2010 pool season. Lifeguard pay starts at \$8.46/hour. Operations attendants begin at \$7.25/hour. The Greater Kansas City American Red Cross and Paul Henson YMCA are currently offering lifeguard certification courses.

All Prairie Village lifeguards must be Red Cross certified before they can start. Applications are available online at www.pvkansas.com. Please contact Chris Engel at 913-381-6464 or cengel@pvkansas.com for further information.

Tax Credits Available to You

There are many tax credits related to your home that may be available to you. The home buyer credit has been extended until April 30, 2010. It is an \$8,000 tax credit* (\$4,000 married filing separate) given to those who purchase a home by April 30, 2010 and close on the property no later than July 1, 2010. Visit www.federalhousingtaxcredit.com for more information.

There are also various energy tax credits available. Congress has reintroduced tax credits for energy-efficiency improvements to existing homes. These federal income tax credits are available for home improvements completed from January 1, 2009 to December 31, 2010 and include insulation, energy-efficient windows and doors, energy-efficient biomass fueled stoves and more. Homeowners can claim up to \$1,500 in combined tax credits. Visit www.energystar.org for more information.

There are federal tax credits available for homeowners who install solar energy systems (including solar water heating and solar electric systems), small wind systems, geothermal heat pumps, and residential fuel cell and microturbine systems. Individuals can receive a 30% tax credit for systems placed in service before December 31, 2016. For more information visit www.energy.gov/recovery/taxbreaks.htm.

The State of Kansas has established the Efficiency Kansas Loan Program which provides low-cost financing for cost-effective energy efficiency improvements to homes (up to \$20,000) and small businesses (up to \$30,000). All household members over 18 will be required to show identification and/or a utility or credit card bill to verify proof of residency. Children under one year of age do not require an ID card and will be admitted free to the pool.

The City reserves the right to revoke membership privileges to anyone attempting to manipulate the number of people included on a household membership.

Pool memberships are Non-Refundable. Daily Admission fees and 10-Swim cards will not be refunded or applied to a membership purchase.

10-Swim cards are only valid for the season in which they are purchased.

ID CARDS

All new pool members are required to obtain a photo ID in the City Clerk's office. Existing members can use their previous card or obtain a new one. ID cards must be presented upon entering the pool complex only by the person to whom the ID card is issued. Any violations or "pass backs" of ID cards may result in forfeiture of your membership privileges for the remainder of the season.

POOL RENTALS

Prairie Village residents may rent the Leisure Pool, Slide Pool, and Diving Well as a package any available evening between June 1st and August 8th after the pool closes to the public. Parties may be held from 8:30 p.m. until 10:00 p.m. The rental fee is \$387. All food must be kept within the concessions area, and will not be permitted in the pool complex until 8:30 p.m., nor will any non-paying or non-member guest. In addition, all pool rules apply during pool rentals. Note: The Pool Manager on duty may close the entire pool complex, or any portions of the pool complex, for any weather, safety or maintenance reason. YOUTH GROUP LESSONS (Up to age 15)

PEE WEE CLINIC (*Up to age 6*) – Introduction to the basic skills of tennis using a variety of games that incorporate fun and learning. Meets Tuesday and Thursday mornings at 8:30 a.m. for 30 minutes. Cost is \$41 per participant. There is a minimum enrollment of 4 and a maximum enrollment of 6.

MIGHTY MITES CLINIC (Ages 7 to 10) - Introduction to the strokes of tennis, including games for fun and fitness. Meets Mondays, Tuesdays, and Thursdays. There will be two different sections for Mighty Mites during Session 1 - one at 9:00 a.m. and one at 11:00 a.m. Both sections are 50-minute classes. Sessions 2 through 4 will have only the 9:00 a.m. section. Cost is \$54 per participant. There is a minimum enrollment of 4 and maximum enrollment of 10.

Prairie Village is a member of the Kansas City Junior Tennis League (KCJTL). In this program, youth ages 8 to 18 develop, improve, and refine their tennis skills. The League consists of weekly clinics, Challenge Days, weekly team matches, and an end-of-year tournament. Cost is \$92 per participant (\$86 for each additional family member on team). No refunds will be allowed for the Kansas City Junior Tennis League team.

For the first hour participants will receive instruction through fun and challenging games. They will then be set up with a challenge match to help determine the first week's ladder. 

EXTERIOR GRANT PROGRAM

The City Council has renewed the Exterior Grant Program after another successful year. The 2010 Program will begin excepting applications on March 1st of this year. For this year's program the council has expanded two of the areas (see map), adding all Prairie Village addresses from 69th St. to 71st St., west of Nall to Reeds and adding all addresses from 71st St. to 75th St. from Roe to Tomahawk in Area One. The boundary for Area Three was expanded east to Delmar St. from 75th St. to 79th St. The previous two years of the program have seen over \$400,000 worth of improvements made to 39 homes in your

neighborhoods. Homeowners located in the designated areas must make a minimum \$5,000 investment on pre-approved projects to qualify for a 20% reimbursement on construction and material costs up to \$2,500. Homeowners that are interested in participating in this year's program may contact City Hall at 913-381-6464 or visit www.pvkansas.com and click on the exterior grant link on the main page. Applications will be accepted March 1, 2010 through September 1, 2010. Funding for the program is limited so apply early.

NEW LAWS FOR TEEN DRIVERS



At first glance, the Graduated Driver's License Law that went into effect on January 1, 2010, can be somewhat confusing. The following is clarification of those changes by explaining each category of license and applicable restrictions:

Instruction Permit (Duration: 12 months)

- Minimum age 14 (If under age 16, written application of parent/guardian required)
- Must pass vision and written examinations
- Must be accompanied by adult in front seat who holds a valid driver's license with at least one year of driving experience (No person except supervising driver can be in front seat)
- NO wireless communication devices while driving except to report illegal activity or to summon emergency help

Restricted License (Duration: 12 months)

- Minimum age 15 (Written application of parent/guardian required)
- Must have held an Instruction Permit for at least one year and completed at least 25 hours of supervised driving
- Must have successfully completed an approved Driver Education course (not required if applying at age 16)

If under age 16, may drive at any time:

- To/from or in connection with any employment
- Most direct route to/from school for the purpose of attendance
- When accompanied by an licensed adult in front seat

During this time:

- Must complete additional 25 hours of supervised driving (10 of the 50 hours total must be at night)
- One non-immediate family member minor passenger (less than 18 years old) is allowed
- NO wireless communication devices while driving except to report illegal activity or to summon emergency help

Full License

- Age 17 (if applying as a first-time applicant)
 - Must pass vision, written and driving exams with appropriate license in hand
 - Must provide proof of age and identification
 - Signed affidavit of parent or guardian, stating applicant has legally completed at least 50 hours of adult (at least age 21) supervised driving with at least 10 of those hours being at night

9-1-1 and YOU

As we all know we are living in a fast-paced world these days. It should come as no surprise the overwhelming majority of us use cell phones to connect and keep connected to everyone around us, whether using the functions of the phone, texting, or email.

Prairie Village Police Department dispatchers answered 40,000 phone calls in 2009, approximately 8,000 which were 9-1-1 calls. The percentage of 9-1-1 landline vs. 9-1-1 wireless calls was split at about 50 percent each. A noticeably large volume of these 9-1-1 calls were non-emergency calls. Cell phone usage has become commonplace over the past few years, and most of us probably know someone who has cancelled home phone service in favor of a cell phone.

While the total number of 9-1-1 calls continues to remain about the same annually, cellular 9-1-1 calls are slowly becoming the majority. While the City would never discourage the use of the 9-1-1 system, it is important to curtail the use of 9-1-1 for non-emergency reasons so the 9-1-1 lines are available for emergency calls. There are a limited number of 9-1-1 lines, and if all lines are busy with other calls, a true emergency might not be answered in a timely manner.

The Prairie Village Police Department has a published non-emergency phone number of **913-642-5151**. Please consider adding it to your home or cell phone contact list. This number is answered 24-hours a day, seven days a week by a dispatcher who will be able to assist you with non-emergency police or animal control-related calls. The call will still be handled quickly and professionally, however, the 9-1-1 emergencies will be realized and handled with top priority.
