Minutes of Nov. 1, 2023

Meeting started at 6:01 pm.

<u>Board Members present:</u> Kevin Dunn (chair), Mark Kaufman (minutes), Mark Morgan, Lindsay Voitik, Beth Held, Kirk Walters.

Other Attendees: James Carney; Bridget Tolle; James Rosa

- 1) Previous minutes of August 2, 2023 were approved unanimously, without any changes.
- 2) Strategic Plan: Measuring City Tree Canopy Kevin suggested that having a fuller discussion of the Strategic Plan once the new Tree Board members join our Board in 2024. It was noted that Tom Jacobs, head of Mid America Regional Council, has done an aerial survey of the entire metro region, including Prairie Village. These results, from 2021, would be available to us without cost. Beth noted that she has worked with Tom in the past, and offered to contact him for an update. Mark M and Lindsay discussed having alternative methods of measuring canopy such as iTree for backups.
- 3) 2024 Arbor Day Poster Contest: The option to proceed with this was discussed by the Board. If we became involved in judging the contest it would be in January. Mark Morgan noted that prior information about this process was posted on the Google Drive, and is available to us. It was noted that in previous years our Board would get started in about September working on this project. It is relatively late in the year to begin at this time. After extended discussion, the Board decided not to become involved with judging for this contest in January of 2024, but might offer to do so again in future years.
- 4) Recommended reading list for Johnson County Library: Kevin encouraged Board members to let him know, over the next week or two, if anyone has any suggested books. The Board also discussed the possibility of creating a "Reading Corner" section of our website, that could contain a variety of types of suggested readings related to the mission of our Tree Board.
- 5) Staff Report: Fall Street Tree Plantings, & Winter Tree Pruning.
  - (a) <u>Fall Street Tree Planting:</u> Bridget noted that the city is planting 103 "replacement trees," mostly street trees, but also some park trees. The Board discussed the various types of trees that are being planted, as well as options for the future.
  - (b) <u>Winter Tree Pruning –</u> It was noted that Kansas City Tree Care will be doing this work for the city during December, January and February. The plan is for this to be

completed prior to March, and before Spring bugs become a challenge to this project.

6) Old Business: Fall Seminar – The Board reviewed this recent event. Various Board members commented on what a high-quality program it was, and that local attendance was very good. Members of the public asked many questions, made many comments, and seemed to become quite engaged. Kevin thanked Bridget for being one of the presenters and for doing an excellent job; she needed to step in as a replacement, shortly before the event. Members of the public reacted positively to the "tree lists" that were available for them. The lists led to some interesting and informative discussions between the presenters and the members of the public who were present.

#### 7) New Business:

- Kevin led Board members in a discussion about who will be "taking minutes" during the Board meetings in 2024. The following was agreed to: February meeting will be Lindsay. For March it will be Beth. In April it will be Kirk. In May it will be Kevin. In June it will be Mark Morgan.
- Recruiting potential new Tree Board members: there are multiple openings at the present time, and Kevin informed Board members that they are permitted to "recruit" new Board members, who will then need to apply, and go through the normal and prescribed selection processes.
- Arbor Day article in the Village Voice: This article will be due during the first week in December, in order to be published in the January/February edition of the Village Voice.
- 8) The next Tree Board meeting is scheduled for February 7, 2024.

The meeting was adjourned at 6:59 pm.

The Publication Summary of Community Highlights was very well received last year. We are therefore incorporating this as an annual submission requirement for the Tree City USA Certification. Each prospective Tree City Community is asked to submit a brief description of their forestry program accomplishments from the past year. This information will be shared with other Kansas communities in booklet form at the Annual Kansas Tree City USA Recognition Day. It is our hope and intention that this information will contnue to facilitate networking among tree managers and to share ideas for making good programs even better.

The City of Prairie Village would like to recognize the Tree Board on their many accomplishments throughout the year. Their focus this year was mainly on tree protection, tree planting, and public education. This year the Prairie Village Tree Board held their annual Arbor Day event on April 29th at Porter Park, A Shagbark Hickory was planted in recognition of Arbor Day and honored the Prairie Elementary Green Team; a group of students who made a positive environmental impact in their school and the community. The event was well attended by many members of the community including students, parents, staff, Mayor, and City Council Members. The Shagbark Hickory is a nice, native addition to the Prairie Village Arboretum. Also, in April on the 26th, the Tree Board and Kansas Forest Service held a State Champion tree measurement training workshop at Taliaferro Park. The group learned what defines a State Champion Tree, how to properly measure trees, and how to nominate them for State Champion. A group of 5th and 6th grade students and their teachers from Highlawn Montessori School participated in this educational workshop. The Tree Board was also measured and nominated a new State Champion Tree that exists in a backyard in Prairie Village. This English Oak was recognized by Kansas Forest Service and added to the Kansas Forest Service State Champion Tree list. Each year the Prairie Village Tree Board coordinates a Fall Seminar where they bring in speakers to discuss various tree topics. This year's topic was a panel discussion on the use of native vs non-native tree species and the benefits that both can provide. Heartland Tree Alliance Program Manager, Sarah Crowder, Multistudio Landscape Architect, Robert Whitman, and Prairie Village Urban Forestry Specialist, Bridget Tolle, spoke on this topic and answered questions provided by Tree Board Chair, Kevin Dunn, and the public. This educational event was also well attended by many members of the community. On July 14th, Prairie Village and surrounding areas experienced a major storm event with wind speeds reaching over 70mph causing widespread, extensive damage to trees. The City coordinated a curbside debris cleanup and removed hazard trees from City parks and rights of way. The City continued to remove dead/diseased/dying/storm damaged trees on City property and is dedicated to replanting every tree that has been removed. Some additional accomplishments include the increased tree trimming and planting budget, a partial tree inventory update, and the continued inspections and enforcement of the City's Tree Protection Ordinance and Landscape Design Standards.

#### A5. Emergency Appropriation: 2 pts

Describe emergency and the process for receiving additional funds to address it

On July 14th 2023 a sever thunderstorm swept through Prairie Village with sustained hurricane force winds reaching speeds greater than 70mph causing widespread damage to trees and structures throughout Johnson County, KS. In response, the City coordinated a citywide curbside tree debris pickup and removed hazard trees and branches from City property. The City Council approved of \$700,000 to be used from the City's emergency account to pay to the debris collection. This is a separate account from normal tree maintenance operations. Ultimately \$565,000 was spent on tree debris collection, removal of storm damaged trees, and trimming of hazardous tree branches. The 35,000 cubic yards of tree debris were taken to local tree recycling centers. The City applied for reimbursement through FEMA. Prairie Village is dedicated to replacing every storm damaged tree that was removed during this storm.

Tree inventory was updated for 2 districts and 1 park within Prairie Village. A total of 845 park and street trees were updated which is 8.84% of the total 9555 City trees.

#### D19. Tree Protection: 4 pts

Summarize tree protection and inspection program

In 2023 the Urban Forestry Specialist inspected 167 home rebuild and major addition sites on a monthly basis to ensure and enforce the protection and planting of trees on public and private property as required by the Tree Protection Ordinance and Landscape Design Standards. 257 trees were removed on these sites, 499 trees were planted, and 553 were protected.

#### E12. Community Forestry Report: 3 pts

Summarize report findings, describe presentation

In Feb of 2023, the Tree Board and Urban Forestry Specialist presented to City Council on the Tree Board accomplishments and Tree Protection Ordinance achievements from 2022. The current state of the urban forest was questioned by council and discussed. Prairie Village has an aging urban forest mostly comprised of 70+ year old Pin Oaks. About 100 of these trees are needing to be removed each year due to disease, storm damage, and decay. Tree Board stressed the importance of planting a diversity of new trees in their place.

#### E23. Youth Education: 2 pts

Describe education program, lessons delivered, attendance

In April of 2023 the Tree Board and Staff met with elementary students on 3 occasions to discuss trees. On April 24th, the Prairie Village Urban Forestry Specialist met with the fifth and sixth grade level students at Highlawn Montessori to discuss urban forestry, her job duties, and the benefit that trees provide to the community. She answered questions from students and heard their own stories and experiences with trees. On April 26th, Kim Bomberger from Kansas Forest Service provided a Champion Tree Measurement Training Workshop with Tree Board members, City staff, and 5th/6th grade students from Highlawn Montessori School. The students answered math questions related to measuring trees, learned about how we measure trees, and discussed the importance trees play in our community. On April 29th, the Tree Board honored the Prairie Elementary Green Team during their Arbor Day event for their role in raising money to plant trees at their school, creating idle free parking areas at their school. and volunteering in their community to pick up trash and mulch park trees. Tree Board members provided information about the native Shagbark Hickory tree. Urban Forestry Specialist explained how to properly plant and care for a young tree, and the Mayor explained how trees are so crucial for the future of Prairie Village.

Planting trees can help reduce utility usage in both the summer and winter when they are planted in the right location. Planting shade trees on the south and west sides of your house can cool your home during hot summer months. Plating evergreens on the north side of your home can create a wind break from freezing winter winds. Planting native trees can provide habitat and food sources for birds and other urban wildlife. Through "Contain the Rain" funded by Johnson County, you can help restore the urban forest of Prairie Village. Some native trees that qualify include Bur Oak, Sugar Maple, and Downy Serviceberry. Apply to get a 50% match up to \$150 each with a limit of 2 trees per household. The project must be completed by October 31<sup>st</sup> of 2024.
