A Message from the Mayor



Dear friends and neighbors,

One of the most important tasks for city government is preparation of the annual budget. Our staff, finance committee, and governing body have been working diligently on the 2025 budget, scrutinizing every expense to ensure that we efficiently provide excellent services and infrastructure that residents expect. By the end of the summer, following public meetings, we will have a final 2025 budget. The proposed 2025 budget is balanced, with emphasis on public safety, parks, infrastructure and services.

The "all-in" number for General Fund expenditures as unanimously recommended by our Finance Committee is approximately \$32 million.

That represents about a 1.3% increase compared to 2024, which is relatively low considering the inflationary environment. That proposed budget keeps the property tax mill levy rate flat at 18.325, continuing forward our rate reduction from 2023 of one mill. The proposed budget maintains a conservative fund balance around 25%, consistent with our historical best practices.

As always, the single biggest line item (around \$16 million) in that operating budget is personnel. We have around 118 full-time-equivalent employees, and another 110+ seasonal employees. The 2025 proposed personnel budget continues to implement our 2022 salary study that identified competitive salary ranges among similar cities in the region, aimed to keep us at the 60th percentile in the market.

Some of the most intense salary competition continues to be with police officers, our largest department budget. Other cities have been ratcheting up their police salaries as we all compete for a shrinking pool of qualified candidates. This budget includes materially increased police salaries to keep pace with that tight labor market. Without these, the cost of turnover and training could be even greater. Those proposed salary increases apply to new and seasoned officers, and would be partially implemented in 2024 to maximize retention and recruitment.

For infrastructure, the proposed budget maintains our commitment to more road investment, which has led to steadily increasing quality of our streets. We again expect to receive matching dollars from the county for major road rehabilitation in 2025. The proposed budget also includes investment for City Hall, Police and Court improvements on our civic center campus. In our parks, capital investments include electric charging stations, trails, play sets and LED lighting.

With this proposed 2025 budget, a median homeowner's total monthly city property tax would be \$71. Daily cost of city services per resident is expected to be around \$3 per day. That includes police, roads, drainage, parks, events, codes enforcement and more. We expect the City portion to remain at around 16% of the overall property tax bill. Our debt is exceptionally low, and our property tax rate remains among the lowest of Johnson County cities. We also expect to expand our popular tax rebate programs again in 2025.

Please familiarize yourself with our proposed 2025 budget and provide feedback to your Councilperson. Our budget priorities are our community priorities. With your help, the 2025 budget will reflect our shared community priorities of public safety, infrastructure, services, parks, events and high quality of civic life.

Public meeting for community center campus study to be rescheduled

The multi-year study of a new Community Center Campus in Harmon Park continues, with the City of Prairie Village, YMCA of Greater Kansas City, and Johnson County Library analyzing feedback gathered from the second public meeting on April 4, 2024, and responses to an online questionnaire. To allow for review and further site design refinement, the previously scheduled meeting on June 20, 2024, has been canceled. A new date for the third and final public meeting will be announced soon.

The questionnaire, which received more than 500 responses, included three site options, and an option for no changes to the park. Fortytwo percent of respondents chose Option B, a co-located community center and library on the northwest portion of the park. Twenty-six percent chose Option A, co-location on the southwest portion of the park; 24 percent chose Option D, no changes; and seven percent chose Option C, the community center located at the northwest portion of the park with the library located elsewhere.

Taking into consideration public feedback, as well as other site factors, the project partners recommendation a to the Prairie Village City Council to move forward with the conceptual design study phase using the Option B configuration at the meeting on May 20, 2024. During this meeting, the council requested additional information prior to proceeding with one site option. The project team is scheduled to return for a second presentation at a City Council meeting in July.

Following the next presentation and after receiving council direction, the project team plans to finalize the site configuration and conceptual design, as well as the funding mechanism and costs, to present at the third public meeting.

After that, the City of Prairie Village, YMCA of Greater Kansas City, and Johnson County Library will determine the path forward. The project partners will negotiate terms prior to a public vote in Prairie Village. If PV residents approve the measure, the City and YMCA will allocate funds to

advance the project, the YMCA will finalize private fundraising, and the entities would each work according to their own processes. collaborating when appropriate, to design and construct their separate buildings. If PV residents reject the measure, the YMCA would need to consider the future of the Paul Henson Family YMCA.

Anticipated costs construction and operation of a community center are expected to be shared between the City and YMCA. The funding mechanism (sales tax, and/or property tax, etc.) and the percentage of cost sharing are yet to be determined. Since funds have already been allocated for a new Corinth Library Branch, it is unaffected by the outcome of the public vote for the new Community Center. The Library Board of Directors has prioritized building a new Corinth Library regardless of the study's outcome. The Library is also concurrently assessing existing Corinth site, and the final location of a new Library facility will be determined by the Library Board.

If the Library Board votes to relocate to Harmon Park and PV residents approve the measure, the Library will work to construct the Corinth Library Branch Replacement in Harmon Park on a timeline informed by their Comprehensive Library Master Plan. If PV residents reject the measure, the Library will consider different locations for the planned Corinth Library Branch replacement to serve this community.

Arbor Day honoree celebrates memory of Dennis Patton

Dennis Patton, Kansas State University Research & Extension's Johnson County horticulture agent & educator for over 35 years, was named the 2024 Arbor Day honoree, in memoriam, by the Prairie Village Tree Board. He was remembered and celebrated at the Prairie Village Arbor Day event on Saturday, April 27th at Wassmer Park. Laura Patton, Dennis' wife, attended the event representing the Patton family. A White Oak was planted in his memory prior to the event.

Dennis had an outstanding impact on Prairie Village, the county and the entire metropolitan area. He was well known for his passion for gardening, for trees and for educating the community about them.



He was well known to thousands of Kansas City residents with his weekly gardening columns in the Kansas City Star, and later in the monthly editions of Kansas City Gardener, as well as various Johnson County government publications. Kevin Dunn, former Tree Board Chair, recalled he found a lot of good practical advice in those columns like "Always consider the right tree for the right location." To his readers, Dennis was the sympathetic voice of someone who could get just as exasperated and just as enthusiastic about growing things in this challenging Midwest climate.

His contributions to Prairie Village included introduction of Black and White Oaks at Windsor Park (part of the Prairie Village Arboretum), key in establishment of the Johnson County Extension Master Gardener demonstration garden at Wassmer Park, and as a dynamic and informative public speaker during his consistent participation in and support of the Tree Board Fall Tree Seminar.
