

**MISSION HILLS MUNICIPAL COURT  
FINE SCHEDULE FOR  
ORDINANCE TRAFFIC INFRACTIONS**

The following fine schedule shall apply in the City of Mission Hills, Kansas for first offense violations of sections of the Standard Traffic Ordinance (STO) classified as Ordinance Traffic Infractions. The description of offenses contained in this schedule of fines is for reference only and is not a legal definition.

**Ordinance 1078, Section 10-106 Generate a False Alarm Signal**

**Each false alarm in excess of three false alarm signals during any one calendar year shall constitute a violation.**

**\$50.00 for first, second and third false alarm violations during such calendar year 4<sup>th</sup> and subsequent offenses are mandatory court appearance.**

\* Denotes Kansas "Moving Violation"

*The State of Kansas requires the court to collect State Assessment Fees in the amount of \$23.50 for moving violations and public offenses. These fees are in addition to the fine listed above.*

**Please Note - any violation that results in an accident is a mandatory court appearance (MCA).**
