CITY COUNCIL

CITY OF PRAIRIE VILLAGE March 21, 2011

The City Council of Prairie Village, Kansas, met in regular session on Monday, March 21, 2011, at 7:30 p.m. in the Council Chambers of the Municipal Building.

ROLL CALL

Mayor Ron Shaffer called the meeting to order and roll call was taken with the following Council members present: Al Herrera, Dale Warman, Ruth Hopkins, Steve Noll, Michael Kelly, Andrew Wang, Dale Beckerman, Charles Clark, David Morrison, Diana Ewy Sharp and David Belz.

Also present were: Wes Jordan, Chief of Police; Bruce McNabb, Director of Public Works; Katie Logan, City Attorney; Quinn Bennion, City Administrator; Chris Engel, Assistant to the City Administrator and Joyce Hagen Mundy, City Clerk.

Mayor Shaffer led all those present in the Pledge of Allegiance.

Congressman Kevin Yoder

Mayor welcomed Congressman Kevin Yoder who addressed the Council and shared some of his experiences in Washington, D.C. and the issues that are before the Congress. Congressman Yoder stated he welcomed input from Prairie Village residents and leaders at any time and shared several ways that he could be contacted.

PROCLAMATION

Mayor Ron Shaffer presentation of Proclamation to Cleo Simmonds honoring him for his ten years of service on the Sister City Committee and his significant role in the establishment of a Sister City relationship with Dolyna, Ukraine. Mayor Shaffer noted

that the City of Dolyna had also prepared a proclamation honoring Cleo and both proclamations were read.

NEW BUSINESS RECOGNITION

Mayor Ron Shaffer recognized Kelly Manning, owner of "The Tavern" in the Village which opened three weeks ago in the Prairie Village Shopping Center. Mr. Manning stated he was pleased to be in Prairie Village and noted the restaurant has been well received by residents. He invited those present to visit "The Tavern".

Diana Ewy Sharp noted "The Tavern" has created an exclusive blend of coffee for Prairie Village. Mr. Manning stated the blend would be available for purchase at Hen House soon.

PUBLIC PARTICIPATION

Jori Nelson, 4802 West 69th Terrace, addressed the Council regarding what she considers extravagant and shocking spending that has been done by some members of the City Council and the Mayor with regards to the travel and conference budget. Ms Nelson stated her comments are not political and that her investigation started from a challenge posted on a Prairie Village Blog.

Ms Nelson stated over \$300,000 was spent in the last ten years. She said that the City only retains receipts for five years, some of the records she received were not as detailed as she had hoped and raised many questions. Ms. Nelson shared some of her findings and in particular questioned the spending of money on national conferences, as reflected by the choice of hotels, transportation and meal expenditure. She also noted that some of the Council members travelled extensively, while others did not travel.

Ms Nelson contacted other area cities and considered the spending by the City of Prairie Village to be excessive in comparison. Ms Nelson expressed concern with the spending, noting the increased property and sales taxes affecting Prairie Village residents as well as the proposed cuts being made to education.

Ms Nelson stated she felt the new travel policy on the Council's agenda this evening should include appointed and elected officials as well as city staff. Retaining the existing reimbursement policy does nothing to address the out of control spending by elected and appointed officials. She does not feel staying in five star hotels and upscale dining to be reasonable expenditures, especially in these difficult economic times. She questioned if the value of the education and benefits received from these conferences were truly worth the price the citizens of Prairie Village are paying for their council representatives to attend.

Jori Nelson stated that she feels some individuals have lost sight of what it means to be public servants, volunteers and acknowledged the pillar of our community who should be leading by example.

Mayor Shaffer acknowledged Ms Nelson's comments thanking her for bringing these issues to the forefront, and stated they will be examined and addressed.
