CITY COUNCIL CITY OF PRAIRIE VILLAGE JULY 7, 2008

The City Council of Prairie Village, Kansas, met in regular session on Monday, July 7, 2008, at 7:30 p.m. in the Council Chambers of the Municipal Building.

ROLL CALL

Mayor Ron Shaffer called the meeting to order and roll call was taken with the following Council members present: Al Herrera, Bill Griffith, Ruth Hopkins, David Voysey, Michael Kelly, Laura Wassmer, Charles Clark, David Morrison, Diana Ewy Sharp and David Belz.

Also present were: Quinn Bennion, City Administrator; Katie Logan, City Attorney; Wes Jordan, Chief of Police; Bob Pryzby, Director of Public Works; Karen Kindle, Finance Director; Chris Engel, Assistant to City Administrator and Joyce Hagen Mundy, City Clerk.

PRESENTATION OF COLOR GUARD

The Prairie Village Police Color Guard presented the colors. Mayor Shaffer led all those present in the Pledge of Allegiance.

PRESENTATION

Mayor Shaffer called forward outgoing City Attorney Charles Wetzler for the presentation of a proclamation prepared in recognition of his 45 years of service to the City of Prairie Village. Mr. Wetzler served as City Prosecutor from 1963 to 1970, Municipal Judge from 1970 to 1973 and City Attorney from 1973 to 2008.
