# COUNCIL CITY OF PRAIRIE VILLAGE September 7, 2004 -Minutes-

The City Council of Prairie Village, Kansas, met in regular session on Tuesday, September 7, 2004, at 7:30 p.m. in the Council Chambers of the Municipal Building.

# **ROLL CALL**

Mayor Ron Shaffer called the meeting to order with the following Council members responding to roll call: Al Herrera, Bill Griffith, Ruth Hopkins, Steve Noll, Greg Colston, Andrew Wang, Laura Wassmer, Pat Daniels, Jeff Anthony, Kay Wolf, Diana Ewy Sharp and David Belz.

Also present were: Barbara Vernon, City Administrator; Charles Wetzler, City Attorney; Lt. John Walters; Robert Pryzby, Director of Public Works; Jamie Shell, Finance Director; and Lori Franke, Administrative Assistant.

A roll call vote was taken with the following members voting "aye": Herrera, Griffith, Hopkins, Noll, Colston, Wang, Wassmer, Daniels, Anthony, Wolf, Ewy Sharp and Belz.

Diana Ewy Sharp questioned the lack of consistency between schools and churches when paying the fee for a short-term special use permit. She noted that St. Ann's paid the permit fee for their Fallfest fundraiser, but Asbury United Methodist Church and Shawnee Mission East did not pay the permit fee for their events.

Barbara Vernon explained that there are no criteria when waiving the permit fee, but typically schools request the fee be waived.

Laura Wassmer asked if a policy could be written addressing permit fees for schools and churches.

Mayor Shaffer assigned the short-term special use permit fee to the Legislative/Finance Committee for further discussion.

Diana Ewy Sharp moved the Council approve a short-term special use permit for St. Ann's Church annual Fallfest fundraiser at 7231 Mission Road on October 9<sup>th</sup> and 10<sup>th</sup> with authorization for a promotional sign to be placed in front of the church facing Mission Road, approve a short-term special use permit for Shawnee Mission East Share Organization for a garage sale fundraiser in the school parking lot on Saturday, October 2<sup>nd</sup> from 8:00 a.m. to 3:00 p.m. with permission for promotional signs from September 1<sup>st</sup> to October 2<sup>nd</sup> with the application fee waived, and approve a short-term special use permit for Asbury United Methodist Church for their annual Community Fall Festival at 5400 W. 75<sup>th</sup> Street on Saturday, October 16<sup>th</sup> from 8:00 a.m. to 7:00 p.m. with the application fee waived. The motion was seconded by Al Herrera and passed unanimously.

# **COMMITTEE REPORTS**

#### **Policy/Services Committee**

# POL2004-15 Consider Project 190707: Somerset Drive Delmar to Fontana

Al Herrera reported that the City has received from Johnson County Stormwater Management Program a "Notification of Intent to Fund" letter for this project. The County plans to pay 75% of eligible Design costs and has reserved funding for this project in 2005. The proposed funding is \$170,000 with an estimated City share of \$42,500 and County share of \$127,500. The County is funding only the design portion at this time. Construction funds will be provided in 2006. The 2005 Budget for Capital Infrastructure Program includes \$168,200 (City \$53,150 and County \$115,050).

Al Herrera moved the City Council authorize the Mayor to execute the "Notification of Intent to Fund" from the Johnson County Stormwater Management Council for Project 190707: Somerset Drive, Delmar Street and Fontana south of 83<sup>rd</sup> Street. The motion was seconded by Laura Wassmer and passed unanimously.

# POL2004-16 Consider Project 190708: Tomahawk Road – Nall to Roe

Al Herrera reported that the City has received from Johnson County Stormwater Management Program a "Notification of Intent to Fund" letter for this project. The County plans to pay 75% of eligible Design costs and has reserved funding for this project in 2005. The proposed funding is \$1,809,400 with an estimated City share of \$452,350 and County share of \$1,357,050.

The 2005 Budget for Capital Infrastructure Program includes \$215,400 (City \$78,500 and County \$136,900). The additional funds are projected for the 2006 Budget.

Al Herrera moved the City Council authorize the Mayor to execute the "Notification of Intent to Fund" from the Johnson County Stormwater Management Council for Project 190708: Tomahawk Road – Nall to Roe. The motion was seconded by Laura Wassmer and passed unanimously.

#### **Insurance Committee**

#### Consider the renewal of Workers Compensation Insurance Coverage with Continental Western

Steve Noll reported that at the August 12, 2004 meeting, the City's Insurance Committee made a recommendation to the City Council to renew the City's Worker's Compensation insurance policy with Continental Western Insurance for 2004-05.

At that meeting, the Committee requested that the premium be recalculated and based upon updated payroll estimates. As a result of those changes, the estimated cost of the policy has increased from \$151,433 to \$156,016.

The 2004 Budget included approximately \$187,000 for workers compensation insurance costs.

Steve Noll moved the City Council renew the City's Workers Compensation coverage with Continental Western Insurance through the state assigned risk pool for 2004–2005 policy year at a cost of \$156,016. The motion was seconded by Bill Griffith and passed unanimously.

# **OLD BUSINESS**

Jeff Anthony requested more information regarding the traffic flow around Corinth Elementary School.

Lt. John Walter explained that the Public Safety Department is still accessing information. He stated that Chief Grover would have more information in October after school had been in session for two months.

Bill Griffith questioned when the work on Mission Road would be completed and if the contractor was in a penalty phase.

Bob Pryzby explained that it was stated in the contract that the contractor have 75<sup>th</sup> Street to 79<sup>th</sup> Street completed prior to the start of school for the Shawnee Mission School District. They are now in a penalty phase because they did not fulfill the contract. The total contract, which not only involves Mission Road but other streets, has a completion date of October 16<sup>th</sup>.

Mr. Pryzby added that the contractor anticipates having all the concrete inlays done this week on Mission Road, and then will pave 75<sup>th</sup> Street to 77<sup>th</sup> Street.

Pat Daniels asked what the penalty fee was. Mr. Pryzby stated that there is a penalty fee of \$100 a day for not completing the Mission Road on time and there is a penalty fee of \$1,000 a day on the major contract.

Ruth Hopkins explained that Resolution 2004-04 "A Resolution of Commitment to Resurrecting the American Dream" was sent from the National League of Cities. She noted that Charles Lyons will speak at the Kansas League of Cities Conference on this topic, and she encouraged council members to attend. Ms. Hopkins also thanked the Mayor for putting this resolution on the consent agenda.
