COUNCIL CITY OF PRAIRIE VILLAGE May 3, 2004 -Minutes-

The City Council of Prairie Village, Kansas, met in regular session on Monday, May 3, 2004, at 7:30 p.m. in the Council Chambers of the Municipal Building.

ROLL CALL

Mayor Ron Shaffer called the meeting to order with the following Council members responding to roll call: Al Herrera, Bill Griffith, Steve Noll, Ruth Hopkins, Andrew Wang, Laura Wassmer, Pat Daniels, Jeff Anthony, Kay Wolf, Diana Ewy Sharp and David Belz.

Council Committee of the Whole

COU2003-17 Consider County Sales Tax Revenue

During the past weeks both the Legislative/Finance Committee and the Council Committee of the Whole have discussed the use of the quarter cent sales tax approved by the public in August, 2002. Although the tax is being challenged in court, it is being collected. Both committees have recommended that the City move forward with identifying projects/initiatives to be funded through this limited tax source.

On behalf of the Council Committee of the Whole, Bill Griffith moved the City Council allocate \$200,000 from the proceeds of the quarter cent special sales tax for the construction of a skate park. The motion was seconded by Laura Wassmer and passed unanimously.

Mr. Griffith noted over the past several months the Council has been struggling with how to become pro-active in encouraging development and redevelopment within the City. It has become apparent that addressing these issues appropriately will require additional funding.

On behalf of the Council Committee of the Whole, Bill Griffith moved the City Council establish a redevelopment reserve fund to be funded with proceeds from the quarter cent special sales tax, less \$200,000. The motion was seconded by Laura Wassmer and passed unanimously.
