COUNCIL CITY OF PRAIRIE VILLAGE January 16, 2001 -Minutes-

The City Council of Prairie Village, Kansas, met in regular session on Tuesday, January 16, 2001, at 7:30 p.m. in the Municipal Building.

ROLL CALL

Mayor Ron Shaffer called the meeting to order with the following Council members responding to roll call: Bill Griffith, Steve Noll, Ruth Hopkins, Bob Pierson, Roy True, Laura Wassmer, Jerry Kelso, Nancy Vennard, Kay Wolf, Diana Ewy Lamberson and Patty Markley.

Also present were: Barbara Vernon, City Administrator; Charles Wetzler, City Attorney; Charles Grover, Chief of Police; Bob Pryzby, Director of Public Works and Doug Luther, Assistant City Administrator.

PUBLIC PARTICIPATION

Mayor Shaffer recognized boy scouts from Troop 91 & Troop 98 present at the Council meeting to earn their merit badge.

John Friar, 5937 Merriam Drive, addressed the Council regarding the Code Enforcement program in the City of Merriam. He expressed concern about having code enforcement under the police department, noting that code enforcement is a civil matter and in his opinion not well suited to enforcement by police personnel. He questioned if such action could raise state constitutional issues and advised the City to look at the legal ramifications of moving the code enforcement officer to the police department. Mr. Friar discussed problems with the Kansas City, Kansas rental licensing program and its impact on privacy issues.

Bill Griffith noted that the moving of the code enforcement program from the Codes

Department to the Police Department is only being considered at this time and should not be
considered a foregone conclusion.

Planning Commission

Kay Wolf reported that at its January 2nd meeting the Planning Commission continued the scheduled public hearing on the request of Highlawn Montessori for a Special Use Permit for a private school at 3531 Somerset Drive until the February 6th meeting. Site Plan approval was given to Lockton Insurance for the installation of a 600-kilowatt backup generator at 7400 State Line Road to be used in emergency situations.

The Board of Zoning Appeals also met and denied a requested variance by Jacob Horowitz for a fence at 3900 West 90th Street.

Mission Road Improvement Committee

Nancy Vennard presented an update on the actions of the Mission Road/Main Street Committee. The committee met last week with representatives of Bucher, Willis & Ratliff facilitating small group discussions. Representatives from city staff, Council, arts, planning, tree board, homes associations and local business areas participated. The groups considered areas of improvement and completed a visual preference survey. The issues discussed included lighting, roundabouts, brick patterns, pavement treatment etc.

OLD BUSINESS

Progress Report on Unsafe Structure at 4507 West 70th Street

Curt Oliver, City Building Official, advised the Council that Mr. Jason Ralston took ownership of this property on November 17, 2000. Building Permits were issued to Mr. Ralston last week to begin the renovation of this property. Mr. Oliver stated that Mr. Ralston was currently working on the structure and should be able to complete the renovation within the next sixty days.

Bill Griffith moved the Council grant Mr. Ralston an additional 90 days to bring the property into compliance with the City codes. The motion was seconded by Ruth Hopkins and passed unanimously.
