The City Council of Prairie Village, Kansas, met in regular session on Monday,

December 4, 2000, at 7:30 p.m. in the Municipal Building.

ROLL CALL

Mayor Ron Shaffer called the meeting to order with the following Council

PUBLIC HEARING

Mayor Shaffer opened the public hearing on the proposed amendment to the 2000

budget for the City of Prairie Village.

City Administrator, Barbara Vernon, reviewed the two proposed changes to the

2000 budget. The first amendment increases the Debt Service fund by \$1,620,000. The

adopted budget did not include revenue from bond proceeds and interest earned on bond

proceeds for the swimming pool improvement project and the expenditure for costs

related to the bond issue.

The second amendment establishes an account for the transfer and expenditure of

tax increment funds received from the Brighton Gardens Project. During 2000, the City

received property tax revenue of \$95,000. Some of these funds were transferred to the

General Fund to reimburse City expenditures related to the project. The balance was paid

to Marriott to reimburse extraordinary costs incurred for the construction of the project.

Bill Griffith confirmed that the TIF Fund is basically a zero balance account for

the handling of TIF proceeds and expenditures.

No one was present to speak on the proposed amendment to the budget. Mayor

Shaffer closed the public hearing at 7:35 p.m.

COU2000-35 Consider Lease Agreement with Metricom, Inc.

The Council previously approved a Special Use Permit to Metricom, Inc. for the installation of antenna on the City's communications tower at 7700 Mission Road and other equipment in the shelter at the base of the tower contingent upon securing a lease agreement from the City. The Council Committee reviewed the proposed lease agreement and recommended the monthly fee be reduced from \$2,500 to \$2,400 per month to be consistent with the fees charged by other jurisdictions in the area.

Nancy Vennard moved the Council approve the lease agreement with Metricom, Inc. for the installation of equipment on the Communications Tower at 7700 Mission Road as amended with a fee of \$2,400 per month. The motion was seconded by Kay Wolf and passed unanimously.
