COUNCIL CITY OF PRAIRIE VILLAGE July 3, 2000 -Minutes-

The City Council of Prairie Village, Kansas, met in regular session on Monday, July 3, 2000, at 7:30 p.m. in the Municipal Building.

ROLL CALL

Mayor Ron Shaffer called the meeting to order with the following Council members responding to roll call: Al Herrera, Bill Griffith, Steve Noll, Terry Frederick, Roy True, Laura Wassmer, Jerry Kelso, Nancy Vennard, Kay Wolf, Diana Ewy Lamberson and Patty Markley.

Also present were: Barbara Vernon, City Administrator; Charles Grover, Chief of Police; Bob Pryzby, Director of Public Works; Doug Luther, Assistant City Administrator and Joyce Hagen Mundy, City Clerk.

PUBLIC PARTICIPATION

Mayor Shaffer acknowledged the presence of Mark Drummond from Boy Scout

Troop 395 who was attending the meeting as part of the requirements for a

communications merit badge.

Bill Brimmacomb, 8208 Juniper, addressed the Council with his concerns regarding the Pine Creek Development at 83rd & Juniper. Mr. Brimmacomb has completed a home in the development and eight other homes are under construction; however, the developer has not completed several of his responsibilities for the development of this property. There is no development identification, the retention basin has not been sodded, the lots have not been maintained and contain long grass and weeds, the required annual inspection and certification of the retention basin has not been done. In Mr. Brimmacomb's opinion the developer has abandoned the project. He noted that other developers have offered to help or take over the necessary remaining work, which could be completed in approximately two weeks; however, Mr. Hickok has not responded to their offers.

Teresa Brimmacomb noted language in the agreement allowing the City after reasonable notice to take action and bill the developer.

Mr. Pryzby advised the Council that a letter had been sent to Mr. Hickok listing twelve items which must be corrected by July 8th.

Mayor Shaffer advised that the City would follow-up with the City attorney on possible action to be taken if the items stipulated in Mr. Pryzby's letter are not corrected by July 8th.

Katie Rhoades, 8201 Rosewood Lane, a neighboring property owner, echoed the concerns of the Brimmacomb's. She stated the grass does not get cut until complaints have been made. The covenant with the adjacent property owners required a backup be in place in the event the developer did not fulfill his obligations.

Communications Committee

Laura Wassmer reported that the Prairie Village website was up and running at wwwpvkansas.com. She acknowledged the work of Doug Luther and other staff for their efforts to have this ready by July 1st. Additional pages covering Public Safety and Public Works will be added by September 1st.

Villagefest Committee

Diana Ewy Lamberson reminded Council members that Villagefest 2000 activities begin at 11:15 a.m. on July 4th. She thanked Council members for their support of the program, especially those who have volunteered to work at the event.

Jerry Kelso acknowledged the excellent work of the Villagefest Committee and recommended Mayor Shaffer send a thank you be written to the committee on behalf of the Council.

NEW BUSINESS

Consider 2000-2001 Employee Benefits

Tom Lewinsohn advised the Council that the City's employee insurance coverage has been provided by Prudential Insurance since 1994. Anticipating a substantial increase in premiums, the City Staff directed the City's consultant (Robert D. O'Byrne & Associates), to solicit bids for employee insurance benefits for the 2000-2001 year.

The City Administrator, Mr. Lewinsohn and O'Bryne staff reviewed the bids. Factors considered in reviewing the bids were the availability of physicians and hospitals, the proposed coverage, the proposed cost and the change of physicians that would be required by the change in providers.

With respect to the Life Insurance component the best bid was from the Standard Insurance Company, which presently has a separate policy for our Police Officers. Their quote is \$.15 per \$1000, versus our current cost of \$.35. The rate is guaranteed for three years and should be a saving to the City of about \$460 @ month.

With respect to the Dental component, it was found that employees would have a greater selection of dentists at essentially the same cost by changing to Delta Dental of Kansas which is a company specializing in dental care on a much large scale than Prudential.

The medical coverage by Prudential had undergone continuous changes of doctors who were moving from Prudential to other carriers. Proposals for the medical coverage went to twelve carriers and nine carriers responded. A thorough review in terms of coverage, doctors, and hospitals indicated that United Health Care was the best choice.

The premiums for the total package would increase from \$174.71 to \$175.96 for single employee coverage. Employee plus one will decrease from \$454.46 to \$446.08 reducing the employee cost to \$121.08, and Family coverage will be \$623.32 with employee cost of \$198.32. The United coverage is almost identical to the current coverage under Prudential with employees having the option to choose between a HMO and Point of Service Plan. Only about six percent the employees will have to select new physicians.

Nancy Vennard moved the City Council accept the proposals by United Health Care for medical coverage, Delta of Kansas for dental coverage, and Standard Life Insurance Co. for the life and AD&D insurance. The motion was seconded by Steve Noll and passed unanimously.

It was noted that these changes would be effective 9/1/00 and in force until 9/1/01, and the present subsidy by the City for this benefit package would remain unchanged.

Pool Update

Mr. Pryzby reviewed the transformer problems experienced at the pool during the past few weeks resulting in the temporary closing of the pool. He acknowledged the assistance of KCP&L, the Fire Department and particularly Dale Warman in getting the problems corrected very quickly. The landscaping is going in and the rails are in route and will be installed as soon as they arrive.

Sister City

Mayor Shaffer shared his experiences on his recent visit to Schaerbeek, Belgium. He and seven others from the City visited the City of Schaerbeek, a suburb of Brussels, which has entered into a Sister City relationship with Prairie Village. The city's representatives were very well received and it is anticipated that a delegation from Schaerbeek will visit Prairie Village next summer.
