- Prior to enrolling, you must schedule the day and time of all 5 lessons with your coach.
- All lessons must be paid for before taking the first lesson. Your coach will ask for proof of payment and the liability waiver before allowing participant to enter water.
- All lessons will be ½ hour, once per week, and must be held between 10:30 a.m. 12:00 p.m. Monday Friday
- Make-up sessions for missed lessons may be rescheduled at the discretion of the coach.
- Missed lessons will not be refunded.

### **AGREEMENT**

Participant and the undersigned understand that if a violation occurs, Participant may be subject to prosecution for such violation.

Participant and such Participant's parent or legal guardian, if Participant is a minor, assume any and all risks associated with Participant's participation in swim lessons and the use of pool facilities, including without limitation the possibility of death, personal injury, or property damage of any kind or nature whatsoever and risks resulting from the condition of the pool facilities, all such risks being known and appreciated by Participant and the undersigned.

The undersigned and Participant covenant not to sue, covenant not to file any administrative claims, waive any action against, and release, discharge and agree to indemnify and hold harmless, the City and its agents, directors, attorneys, employees, insurers, assigns, successors, and anyone acting for or on their behalf, from any and all claims or liabilities, including without limitation those for death, personal injury, or property damage of any kind or nature whatsoever, arising, or alleged to have arisen, out of, or in the course of, Participant and/or participant family member's use of pool facilities. This Waiver and Release extends to all claims of every kind or nature whatsoever, foreseen or unforeseen, known or unknown by Participant and the undersigned.
