Kansas State House Bill 2502

Kansas State House Bill 2502 became effective on July 1, 2016, which authorizes legally qualified Municipal civilian employees to conceal carry while engaged in their duties. Employees who enter onto "private property" during the course of their duties are required to comply with any restrictions imposed by that property owner. Employees must also abide by the posted signage and security measures with regard to the prohibition of concealed handguns in certain public buildings. While the City does not anticipate many, if any, civilian employees to conceal carry - we wanted residents to be aware of the law that was enacted. Prairie Village Statuary Maintenance

Prairie Village is home to hundreds of public sculptures, monuments, and fountains, which add beauty and civic pride to our neighborhoods. Recognizing that it is essential to maintain the community's statuary, the City formed a Statuary Committee with the purpose of preserving existing items and to encourage others to enjoy the art pieces. Recently, Paul Benson was hired to assist in the cleaning and maintenance of City owned statues. Benson is a Prairie Village resident and is currently a Conservator of Objects at the Nelson-Atkins Museum of Art. He also has a private conservation business. Benson spoke to the importance of maintaining the statuary. "When they look good it implies that the neighborhood looks good. Many people like the appearance of moss or lichen covered sculptures, but these growths are damaging to the stone on which they grow. The same is true of mottled colored bronze sculptures." Benson's work ensures the statuary's continued existence for future generations to enjoy.







2017 Prairie Village Budget

The annual budget serves as a financial plan, provides guidance to City staff and communicates the City's financial condition. Most importantly, it presents the Governing Body's vision for the community by describing how public funds will be spent in order to achieve policy objectives.

Property Tax: Tax on real estate and personal property. It is computed by applying the City's mill rate to the County's assessed valuation.

Sales Tax: Tax comes from two sources: Local Sales Tax and County Sales Tax.


Franchise Fees: Franchise fees are charged on major utilities within the City. The fee is 5% of gross receipts as defined and permitted by state statutes.

Charges for Services: Includes revenue which is a charge for contract services and special assessments to recipients of certain services.

Intergovernmental: Includes revenues provided by other jurisdictions, primarily the State and Federal governments.

Other Revenues: Includes use tax, motor vehicle tax, liquor tax, license & permits, recreation fees, fines, interest income and miscellaneous revenue.

How are your property taxes used?








Your property tax bill is divided between several entities of which the City is only 16%

The 2017 budget does not include a mill levy rate increase. The mill levy rate was last increased in 2012 by 0.6 mills.

What services are provided by City Programs?



2017 Budget by Department








Capital Infrastructure Program

The City maintains a four-year **Capital Infrastructure Program (CIP**) to aid the City Council and staff in planning and budgeting for the City's infrastructure needs. The CIP is reviewed and updated each year during the budget process. The majority of the funding for the CIP comes from the General Fund. Other funding sources include bond proceeds, the gas tax, the stormwater utility fee, grants, participation by neighboring cities and 1/3 of the liquor tax which is required to be spent on parks and recreation programs.

2017 Capital Improvement Program Funding Sources



The CIP is divided into five sections:

Parks: Includes plans for redevelopment and replacement of existing park structures and materials.


Drainage: Includes plans for replacement of components of the City's storm drainage system.

Streets: Includes plans for major improvements that extend the life of the City's street system.

Buildings: Includes plans for replacement or major improvements that extend the life of the City's buildings.

Sidewalks & Curbs: Includes plans for replacement or major improvements that extend the life of the City's sidewalk and curb system. Also includes plans for additions to the system to comply with the City's sidewalk policy or ADA regulations.

PUBLIC SAFETY

Holiday Safety Tips

The winter time presents some new challenges to protect yourself and your property. Unfortunately your home can become a target during the holiday season so please take a moment to review these simple but important safety measures.

Lock your doors and windows at all times - even if you are away for only a few minutes. Remember, if you can get into your home without using a key so can burglars. Outside security can be as important as inside security. Do not keep a spare key in a hiding spot around your house; burglars know these hiding spots. Keep all sheds, gates, and garages locked when not in use. Use security lights to help light the outside and warn away intruders - burglars will often bypass the well lit home for the residence with poor lighting.

If you are expecting a package delivery, have someone home to accept it, leave it with a trusted neighbor, or have the delivery person hide it out of sight from the main roads. A package left outside for a few hours is not only a target to be stolen, but an indication to a burglar that no one is home.

When you go on holiday trips or to visit family and friends, do not forget to take a few easy steps to protect your property. Tell someone close to your home where you are going and when you will return. Call the Police Department for a house watch on your residence. Cancel paper, mail, and any other regular deliveries to the home. A pile of newspapers is a sure sign that someone has not been home for a while. Set timers on lights, radios, or TVs to give the appearance that someone is home and moving around the residence. Ask a trusted friend or neighbor to keep an eye on your home while you are away. Ask a neighbor to make tire tracks in the driveway when it snows to give the appearance someone is home. Do not post your travel plans on social networking sites like Facebook or Twitter. You want only people you trust to know when your home will not be occupied.

After the season is over don't let your guard down because all of the presents have been opened. When you take the trash out after the holidays, avoid taking large product boxes out to the curb. Cut the boxes up and turn the labels inside out so no one knows what was in the box. Leaving a large flat screen TV, computer, or laptop box on the curb tells everyone that drives by what there is to steal in your home. Please take a few minutes of your time now to help safeguard your home and your family. Please be safe and have a happy holiday season!











Tree Plantings in Prairie Village

Area volunteers from Heartland Tree Alliance joined Prairie Village Public Works this fall to plant, mulch, and stake 13 trees in Porter Park. The tree plantings were made possible through the Kansas Forest Service and the Landscape Scale Restoration Competitive Grant Program (LSR) of the USDA Forest Service. This competitive grant program allows state forestry agencies to submit proposals to address resource concerns and issues in their states. With the Emerald Ash Borer present in Prairie Village, funding from the LSR allowed the Kansas Forest Service to partner with local communities to combat an infestation of the EAB in eastern Kansas. In 2015, Windsor Park received new plantings through this grant program.

One piece of the grant effort has been to educate the public about why it is necessary to diversify the community forest, especially on privately-managed lands. The plantings in Windsor and Porter Parks will allow residents to watch living exhibits of many kinds of trees grow that are suitable for planting in their yards and landscapes. A post with identifying information has been placed in front of each of the recently planted trees in both parks.

Heartland Tree Alliance, a program of Bridging The Gap, creates advocates in the Kansas City metropolitan for a healthy community forest. Their mission is met by educating and training volunteers to assist with tree plantings, tree pruning and other tree care needs. They partner with local municipalities to complete this work on public property throughout a nine county area. The planting in Porter Park was successful due to the 20 volunteers that joined Public Works out in the mud.



2016 Park Improvements

The 2016 park improvement projects are almost complete. Improvements in Porter Park include a new nature play area to enhance the play experience, soccer and baseball field improvements, and walking trail extension to enhance connectivity. Windsor Park improvements feature a new nature play area, new park benches and tables, and drainage improvements to the baseball field. New and improved play sets were installed at Taliaferro, Bennett, and Windsor Park. Thank you to the residents for their patience during construction. We hope you enjoy the new amenities!

New Solid Waste Serivces

The City Council has approved a 10 year contract with Republic Services to begin collecting trash, recycling, and yard waste on January 1, 2017. The process of changing services for approximately 8,400 homes will likely be challenging. We appreciate everyone's patience and cooperation in the process that will also include delivery of approximately 17,000 new carts. Deffenbaugh plans to recover their carts during the last collection week in December. There will be an additional mailer sent to each participating residence that will contain more detailed and specific information in the next few weeks.

The following items highlight some key points:

- The collection of trash, recycling, and yard waste will remain unchanged – with the improved exception of now being allowed 12 yard waste bags/containers/bundles each week throughout the
- Residents will be able to select from an expanded option of cart sizes (35-65-95 gallon). The most common cart size is 65 gallons. We anticipate new cart delivery occurring December 15-22, 2016.
- Maintaining the current weekly route schedule
- Special collection for residents with hardships
- Overflow stickers for extra bags will remain at \$1.25 each
- The first year rate adjustment will increase from \$14.50 to \$16.00 per month.
- Large item pick up will still be conducted on an annual basis
