# Meadowbrook Park **Playground: Let the Kids Vote**

Johnson County Park & Recreation District wants to get the children involved by helping pick the design of the playground to be built at the future Meadowbrook Park at 91st and Nall.

JCPRD evaluated eleven proposals from six different companies for the new playground. The choices were narrowed to three designs, and on July 4 at VillageFest kids ages 2-12 will be encouraged to vote on their favorite design. Each design will be represented at the festival with video displays.

The goal is to develop a one-of-a-kind destination playground incorporating the most current elements of play on the market, or even more desirable, unique play elements that are comprised of new designs that have not been utilized in the region or area. There will be two general areas with play value and variety for ages 2 to 5 years and 5 to 12 years. Other guidelines for the proposals include creativity and originality that is visually appealing to children and adults. It also needs challenging equipment with safety, ADA compliance, and inclusive play consideration. Additionally, durability and ease of maintenance of equipment with a strong warranty are important.

The playground will cover approximately 15,000 square feet or one third acre and will be located near the new activity center. The surfacing materials for the playground use areas will be a combination of synthetic turf and bonded rubber. The projected budget for the playground is over \$700,000. Completion is planned for Spring 2018.

# POLICE DEPARTMENT

### What Animal Control Wants You to Know

Community Service Officers (CSOs) are responsible for enforcing the City's animal control ordinances. Officers normally work seven days per week responding to citizen requests and patrolling the City to identify stray animals or animals violating the City's leash law. One of their goals is to assist residents with animal related issues, as well as providing guidance on being responsible pet owners.

The following sections highlight a few of the City's most common issues or questions. The following does not represent the entire animal control chapter of City code, but serves to answer many common questions. For a copy of the complete Animal Control and Regulations section, please see Chapter 2 of the City Municipal Code.

#### LOOSE ANIMALS AND PROPER CONTROL

It is considered unlawful to permit any dog to run at large within the City. Running at large is when a dog is not firmly attached to a hand-held leash and under physical control of the owner. It is also considered running at large if the dog is not prevented from making uninvited contact with humans or animals. This includes situations when the dog is on a leash.

Cats do not have a leash law; however, a cat entering the property of anyone who has already complained orally or in writing to the neighbor is in violation of City code.

No animal is allowed to cause damage while off their property.

Report your lost pet to Animal Control! We are often times the first call someone makes when they find a loose pet.



A public nuisance is any animal that excessively, continuously, or at an untimely hour makes noise. Dogs are allowed to bark, but not in excess. Chasing cars or people or damaging property are also considered a public nuisance.

#### STRAY OR FERAL CATS

The City does respond to calls involving sick, injured or destructive cats, but does not respond to calls related to stray or feral cats. The Prairie Village Police Department asks residents to not feed, water or harbor loose cats. Stray cats will likely return to their proper home and feral cats are wild animals that can fend for themselves.

### LICENSING/RABIES INOCULATION

The owner of any dog and/or cat does need to register their animal with the City. Proof of a current rabies vaccination is required. It is required that every animal maintain a current rabies vaccine.

An animal should be licensed within 30 days of being brought into the City or attaining six months of age. This applies to foster animals as well. There is no license fee for service/work dogs as long as there is adequate proof the dog is fully trained as a service/work dog, and is current for the year on its rabies vaccination.

#### **ANIMAL BITES**

A bite is considered any break in the skin. It is the duty of anyone having knowledge of a bite or attack to report it to Animal Control or the Police immediately, or as soon as practical.

# **Prairie Village Streetlights**

Prairie Village purchased the streetlight system, consisting of 2,062 streetlights spread throughout the City, from KCP&L in 2016. The streetlight system contained 334 LED lights at the time of purchase and the City is in the process of upgrading the remaining 1736 streetlights to LED's now. The LED heads will last longer than the existing heads, require significantly less maintenance, reduce the frequency of outages, and save on electricity costs. For example, the LED upgrades are projected to decrease the yearly electricity costs from \$94,000 to \$53,000 for an estimated savings of \$41,000 per year.

The City currently contracts with Black & McDonald for streetlight repair and maintenance. Residents can report outages, lights that stay on during daylight hours, intermittent lights, and any other damages or maintenance needs by calling 913-385-4647.
