Agenda Item: Discussion regarding city priorities for 2010

#### BACKGROUND

This is an exciting time to be a part of Prairie Village City Council and staff! There are a number of significant initiatives that are currently being discussed and implemented by the City Council and city staff.

City Council participated in a Council retreat / worksession on February 6<sup>th</sup>. During the meeting, the council discussed 6 of the 10 programmatic initiatives included in Village Vision. The other 4 programmatic initiatives will be discussed at the special committee meeting on Monday, April 26<sup>th</sup> and include:

- F. Updating Ordinances and Code
- G. Improving public facilities and service delivery
- I. Enhancing parks and open space
- J. Promoting arts, culture and activities

During the Feb. 6<sup>th</sup> worksession, Council discussed additional initiatives and projects that are not currently being facilitated. The list includes significant and worthwhile projects that will shape and enhance Prairie Village's future. Given current Council and staff resources and budget limitations, all of the projects cannot be completed within the next year; therefore a prioritization process is needed.

Staff desires direction regarding priorities for the next 18 months. The projects and initiatives listed below are beyond the day to day operations of the City such as public safety, public works maintenance, processing permits, licensing, resident inquiries, inspections, code enforcement, court activities, etc.

Specific projects/initiatives are accomplished in the 5-10% of the staff / Council resources not already committed to the general day-to-day operations of the city. To facilitate the prioritization of projects, staff has attached a list of projects/initiatives currently underway and those which are not currently receiving adequate resources. It is anticipated that Council will add to the list of projects/initiatives not receiving adequate resources at the April 26<sup>th</sup> meeting. Based on the completed list, Council can then determine which projects/initiatives should be the focus for the upcoming 18 months.

Council's direction will help identify the focus of city resources (budget, Council time, staff time) in the coming year. If additional items are added to the list, it will be helpful to understand the projects that are less of a priority.

Improvements to the streetscape and renovation to comfortably accommodate multimodal transportation can have a dramatic impact on the way residents and visitors experience the City.

#### Programmatic Initiative D: Maintaining and Diversifying the Housing Stock

Most of the community's housing stock is over 50 years old, an age at which regular maintenance becomes increasingly important in order to avoid structural deterioration. While existing housing is very similar in size and character, it can be adapted and supplemented with a wider variety of housing choices which may better meet changing needs and lifestyles.

#### Programmatic Initiative E: Emphasizing Architecture and Design Sensitivity

Design standards need not relate to particular architectural style, but more importantly to urban design issues like building position on a site, height, massing, street orientation, etc. The focus should be on the quality and durability of building materials and on the proper configuration of a few exterior elements.
